ORDINANCE NO. 26-079

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

An unplatted tract in the Northwest Quarter of Section 5, Township 27, South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the southwest corner of the Northwest Quarter of the Northwest Quarter of Section 5; thence east along the south line of the Northwest Quarter of said Northwest Quarter to the east line of the west thirty and twenty-one hundredths (30.21) acres of the Northwest Quarter of said Northwest Quarter; thence north along said east line to the north line of the south sixteen and twenty-one hundredths (16.21) acres of said west thirty and twenty-one hundredths (30.21) acres; thence west along said north line to the west line of said Northwest Quarter; thence south to the point of beginning.

SECTION 2. SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-080

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tract in the Northwest Quarter of Section 28, Township 27 South, Range 2 East of the 6th P.M.; U.S. Highway 54 right-of-way and Kansas Turnpike right-of-way adjacent to the unplatted tract more fully described as follows:

Beginning at the intersection of the east line of the Northwest Quarter of Section 28 and the south right-of-way line of the Kansas Turnpike; thence west along said right-of-way line to the west line of the east half of said Northwest Quarter; thence north along said west line to a point 1320 feet south of the north line of said Northwest Quarter; thence east 495 feet; thence north along a line parallel to and 495 feet east of the west line of the east half of said Northwest Quarter to the north line of U.S. Highway 54; thence east along said north line to the east line of said Northwest Quarter extended from the south; thence south to the point of beginning.

SECTION 2.
