ORDINANCE NO. 26-087

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the southwest Quarter of Section 27, Township 27 South, Range 1 West of the 6th P.M. more fully described as follows:

Beginning at a point five hundred eighty-seven and eighty-five hundredths (587.85) feet south and three hundred three (303) feet west of the northeast corner of said southwest Quarter; thence west along a line parallel to and five hundred eighty-seven and eighty-five hundredths (587.85) feet south of the north line of said southwest Quarter to a point seventy-five (75) feet east of the west line of the northeast Quarter of said southwest Quarter; thence south to the south line of Atchison, Topeka and Santa Fe Railroad right-of-way; thence east along said Railroad right-of-way to a point south of the point of beginning; thence north to point of beginning.

SECTION 2. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.
