ORDINANCE NO. 26-093

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Northwest Quarter of Section 11, Township 28 South, Range 1 East of the 6th P.M. more fully described as follows:

Beginning at the point of intersection of the east line of Highway K-15 and the south line of Craig's Addition; thence east to the east line of Clifton Avenue; thence south along the east line of Clifton Avenue to a point one hundred fifty-two (152) feet north of the south line of said Northwest Quarter; thence west to a point three hundred (300) feet west of the east line of the west one-half of said Northwest Quarter; thence south to the south line of said Northwest Quarter; thence west to the east line of Highway K-15; thence northwesterly to point of beginning.

SECTION 2. SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
