ORDINANCE NO. 26-095

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Unplatted tracts in the southwest Quarter of Section 1, Township 28 South, Range 1 East of the 6th P.M. more fully described as follows:

Beginning at the southeast corner of the northeast Quarter of said Southwest Quarter; thence north three hundred thirty-six and fifty-eight hundredths (336.58) feet; thence west to the east line of George Washington Boulevard; thence southeasterly to the south line of the northeast Quarter of said southwest Quarter; thence east to point of beginning.

SECTION 2. SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
