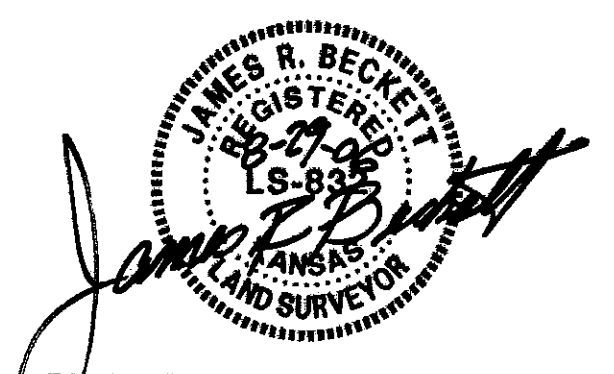

WE, PROFESSIONAL ENGINEERING CONSULTANTS, P.A., ENGINEERS AND SURVEYORS IN AFORESAID STATE AND COUNTY, DO HEREBY CERTIFY THAT OF THIS 29th DAY OF August, 2006, WE HAVE SURVEYED AND PLATTED OAK CREEK 2ND, AN ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS, INTO LOTS, BLOCKS, STREETS, AND RESERVES; THE SAME BEING A REPLAT OF, AND DESCRIBED AS FOLLOWS:

A PORTION OF OAK CREEK, AN ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS; MORE PARTICULARLY DESCRIBED AS FOLLOWS: LOT 2, BLOCK 1, LOTS 5, 6, 7, AND 8, BLOCK 2, LOTS 1, 2, 3, AND 4, BLOCK 4, RESERVES G, J, K, AND R, TOGETHER WITH ALL OF 19TH STREET NORTH AS PLATTED WITHIN SAID OAK CREEK ADDITION, AND A PORTION OF RESERVE P AND CHATEAU PARKWAY, LYING SOUTH OF THE FOLLOWING DESCRIBED LINE; COMMENCING AT THE SOUTHWEST CORNER OF LOT 4, BLOCK 2, OF SAID OAK CREEK ADDITION; SAID POINT BEING ON A CURVE TO THE LEFT, HAVING A RADIUS OF 1233.00 FEET, A CHORD BEARING OF N25°52'59"W, AND A CHORD DISTANCE OF 54.15 FEET; THENCE ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 2°30'59", AN ARC DISTANCE OF 54.15 FEET TO THE POINT OF BEGINNING; THENCE BEARING S62°51'31"W, A DISTANCE OF 84.00 FEET TO THE POINT OF ENDING.

ALL PUBLIC EASEMENTS LYING WITHIN THE ABOVE DESCRIBED TRACT OF LAND ARE HEREBY VACATED AND REPLATTED BY VIRTUE OF KSA 12-512(b) AMENDED.

RESERVE "B" IS HEREBY PLATTED FOR PRIVATE DRIVE, ENTRY MONUMENTS, GATES, DRAINAGE, LANDSCAPING, SIGNAGE AND UTILITIES. RESERVES "C", "D", AND "E" ARE HEREBY PLATTED FOR BERMS, WALLS, FENCES, ENTRY MONUMENTS, DRAINAGE, PONDS, WATER FEATURES, LANDSCAPING, RECREATIONAL USES, SIDEWALKS, AND UTILITIES. RESERVE "F" IS HEREBY PLATTED FOR LANDSCAPING, DRAINAGE, RECREATIONAL USES, AND UTILITIES. RESERVES "G" AND "H" ARE HEREBY PLATTED FOR LANDSCAPING, WATER FEATURES, SIGNAGE, ENTRY MONUMENTS, DRAINAGE, SIDEWALKS, AND UTILITIES. RESERVES "I", "J", "K", AND "L" ARE HEREBY PLATTED FOR LANDSCAPING, SIGNAGE, ENTRY MONUMENTS, DRAINAGE, SIDEWALKS, AND UTILITIES. RESERVES "M" AND "N" SHALL ALLOW FOR PUBLIC ACCESS ACROSS AT VARIOUS LOCATIONS FOR DRIVEWAYS, AS APPROVED BY THE CITY ENGINEER. RESERVES "O" THROUGH "Q" ARE HEREBY PLATTED FOR LANDSCAPING, PONDS, DRAINAGE, SIDEWALKS, AND UTILITIES CONFINED TO EASEMENTS. RESERVES "A" THROUGH "Q" SHALL BE OWNED AND MAINTAINED BY AN OWNER'S ASSOCIATION TO BE FORMED WITHIN OAK CREEK 2ND.

ALL ABUTTER'S RIGHT OF ACCESS TO AND FROM GREENWICH ROAD OVER AND ACROSS THE EAST PROPERTY LINE IS HEREBY GRANTED TO THE CITY OF WICHITA, PROVIDED HOWEVER THAT THERE SHALL BE ACCESS TO GREENWICH ROAD AT ONE LOCATION AS SHOWN.

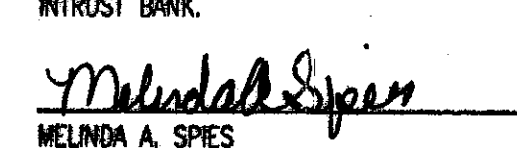

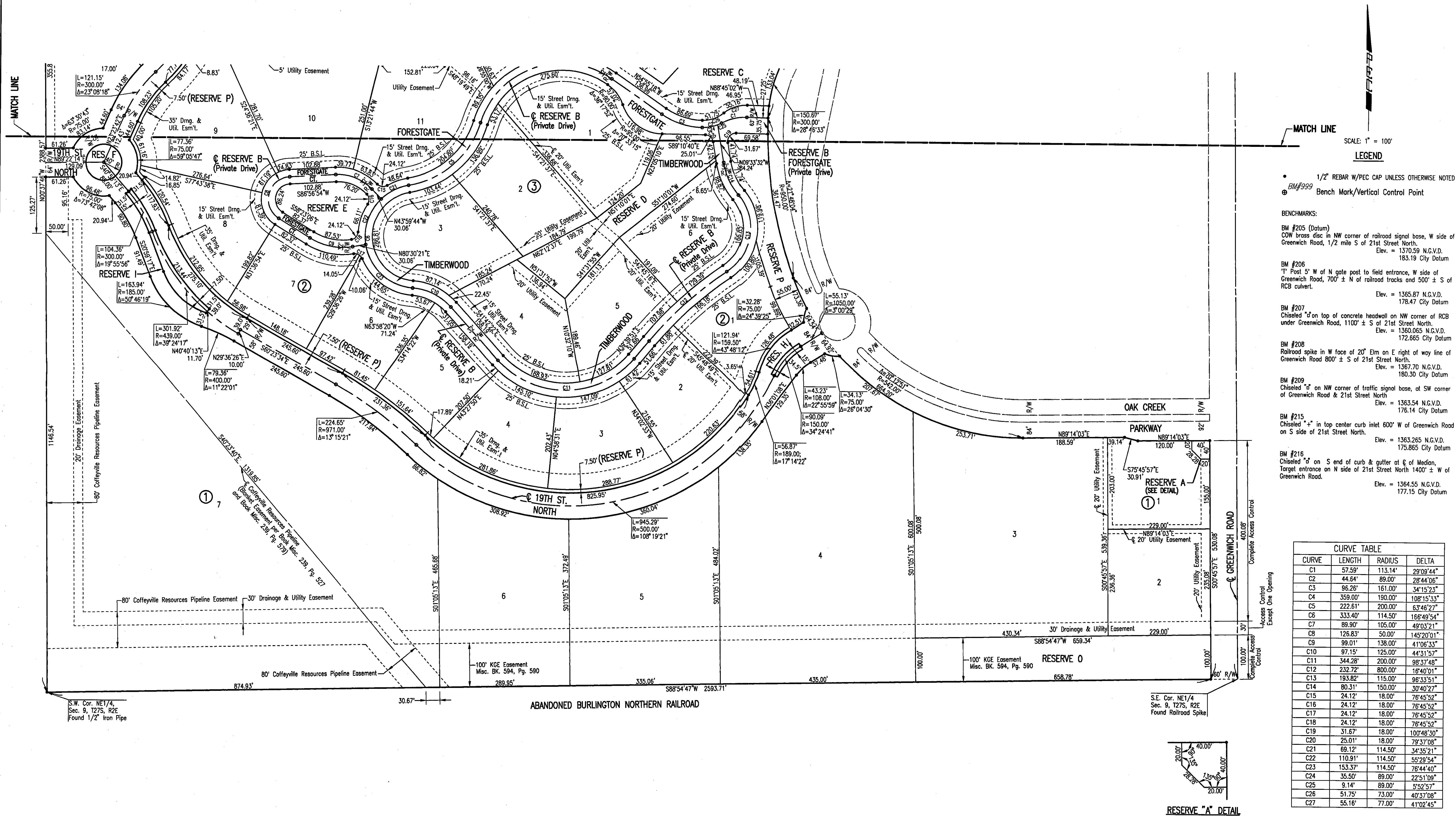
