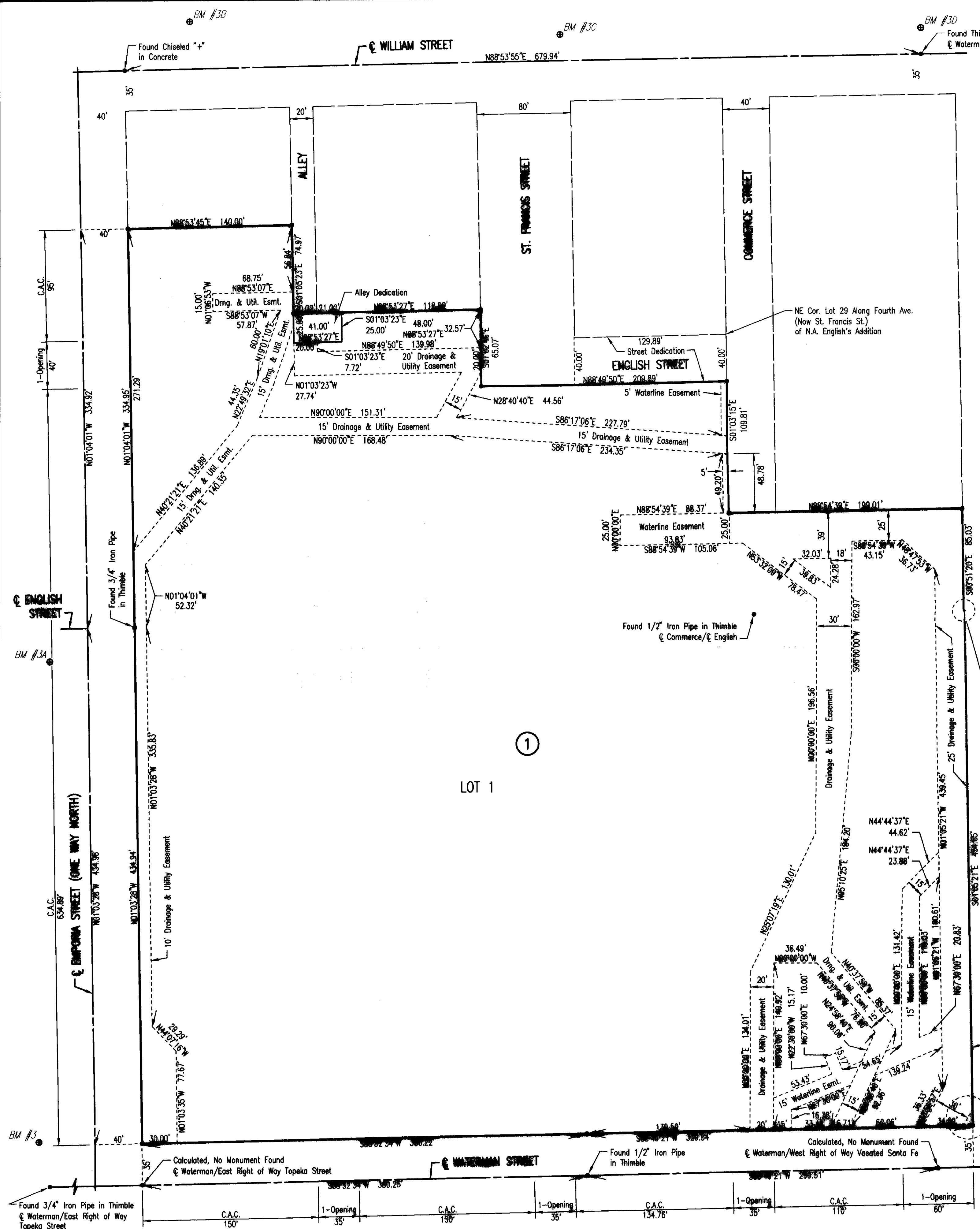
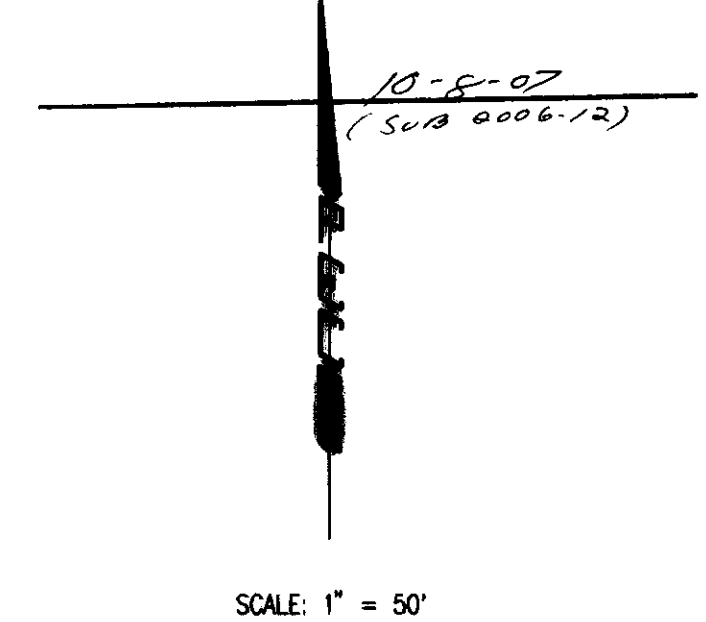

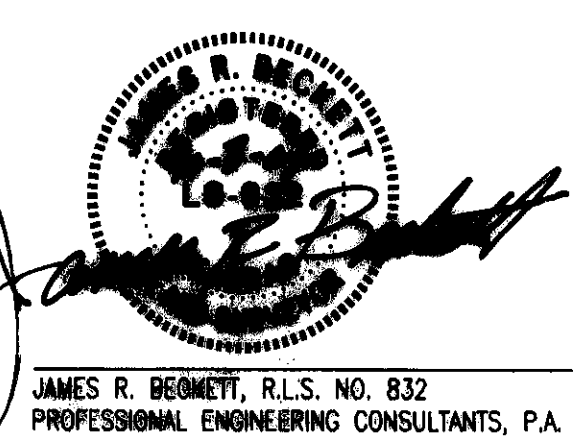
THIS 16th DAY OF October, 2007, WE HAVE SURVEYED

AND PLATTED SEDGWICK COUNTY ARENA, AN ADDITION TO WICHITA, SEDGWICK COUNTY,
KANSAS, INTO A LOT AND BLOCK, THE SAME BEING DESCRIBED AS FOLLOWS:

A RE-PLAT OF PORTIONS OF N.A. ENGLISH'S ADDITION TO THE CITY OF WICHITA
DESCRIBED AS FOLLOWS:

ODD NUMBERED LOTS 21 THROUGH 75 ALONG EMPORIA AVENUE; EVEN NUMBERED LOTS
28 THROUGH 76 ALONG FOURTH AVENUE (NOW ST. FRANCIS STREET), TOGETHER WITH
THE 20 FOOT ALLEY ADJACENT ON THE WEST; THE WEST 130 FEET OF ODD NUMBERED
LOTS 29 THROUGH 75 ALONG FOURTH AVENUE (NOW ST. FRANCIS STREET); THE EAST
130 FEET OF EVEN NUMBERED LOTS 42 THROUGH 76 ALONG FIFTH AVENUE (NOW SANTA
FE STREET), TOGETHER WITH 29 FEET OF VACATED FIFTH AVENUE (NOW SANTA FE
STREET) ADJACENT TO LOTS 42 THROUGH 44 AND 30 FEET OF VACATED FIFTH AVENUE
(NOW SANTA FE STREET) ADJACENT TO LOTS 46 THROUGH 76, TOGETHER WITH ALL OF
ENGLISH STREET FROM THE EAST LINE OF EMPORIA STREET TO THE EAST LINE OF FIFTH
AVENUE (NOW SANTA FE STREET); ALL OF FOURTH AVENUE (NOW ST. FRANCIS STREET)
FROM THE NORTH LINE OF WATERMAN STREET TO THE NORTH LINE OF LOTS 29 AND 30
ALONG FIFTH AVENUE (NOW ST. FRANCIS STREET); ALL OF THE 40 FOOT COMMERCIAL
STREET DEDICATION FROM THE NORTH LINE OF LOTS 41 AND 42 BETWEEN FOURTH AND
FIFTH AVENUES TO THE NORTH LINE OF WATERMAN STREET BETWEEN FOURTH AND FIFTH
AVENUES.

ALL PUBLIC EASEMENTS LYING WITHIN THE ABOVE DESCRIBED TRACT OF LAND ARE

ALL ABUTTER'S RIGHT OF ACCESS TO AND FROM EMPORIA STREET OVER AND ACROSS
THE WEST PROPERTY LINE AND TO AND FROM WATERMAN STREET OVER AND ACROSS THE
SOUTH PROPERTY LINE IS HEREBY GRANTED TO THE CITY OF WICHITA, PROVIDED
HOWEVER THAT THERE SHALL BE ACCESS TO FIVE OPENINGS AT LOCATIONS AS SHOWN.

THE STREET AND ALLEY ARE HEREBY DEDICATED TO AND FOR THE USE OF THE PUBLIC.

EASEMENTS FOR THE CONSTRUCTION AND MAINTENANCE OF PUBLIC UTILITIES ARE HEREBY
GRANTED.

A DRAINAGE PLAN HAS BEEN APPROVED FOR THIS PLAT. ALL DRAINAGE EASEMENTS,
RIGHTS-OF-WAY, OR RESERVES SHALL REMAIN AT ESTABLISHED GRADES AND
UNOBTAINED TO ALLOW FOR THE CONVEYANCE OF STORM WATER, UNLESS MODIFIED
WITH THE APPROVAL OF THE CITY ENGINEER.
