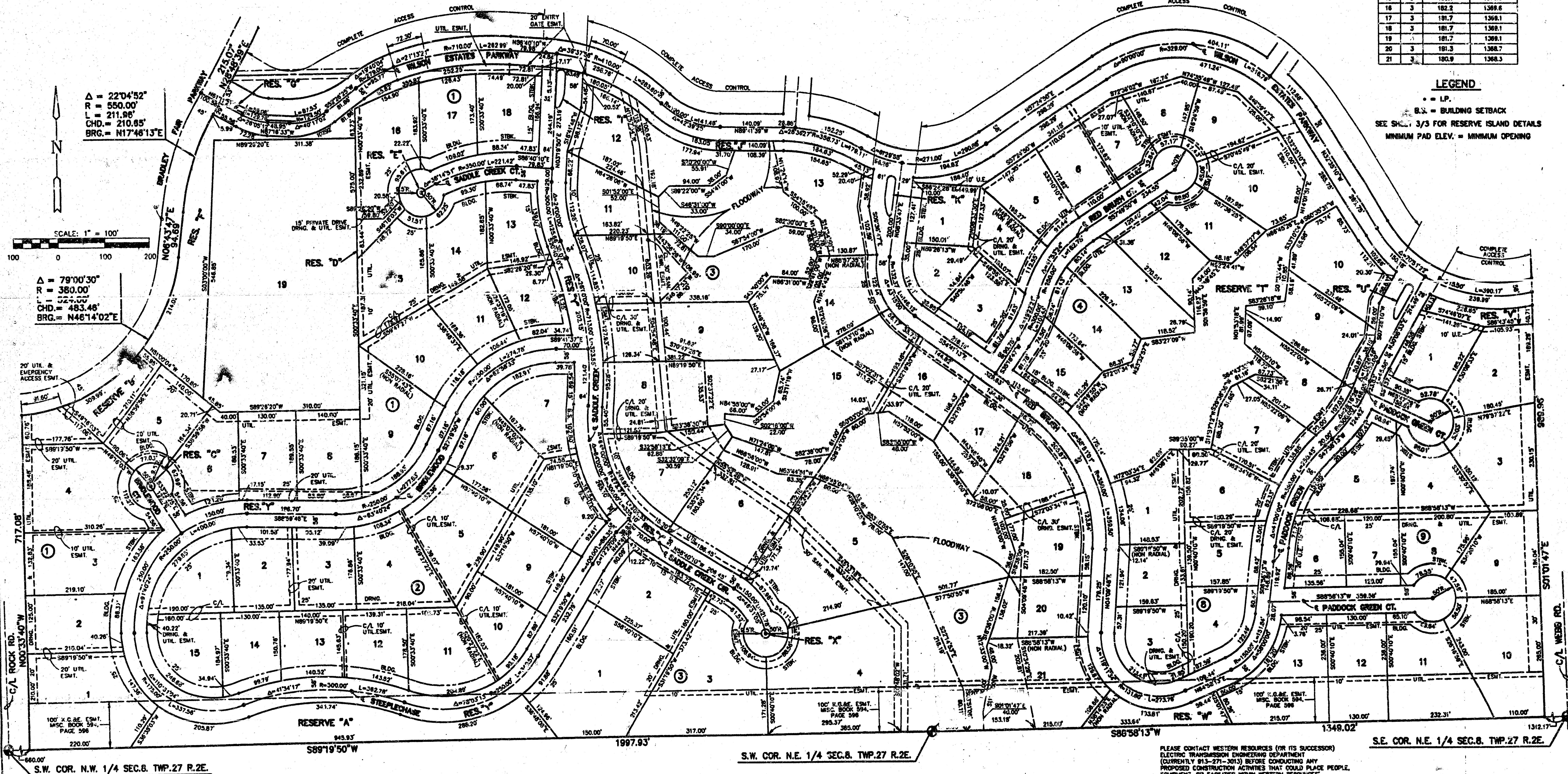

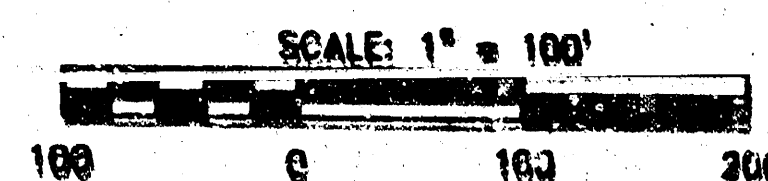
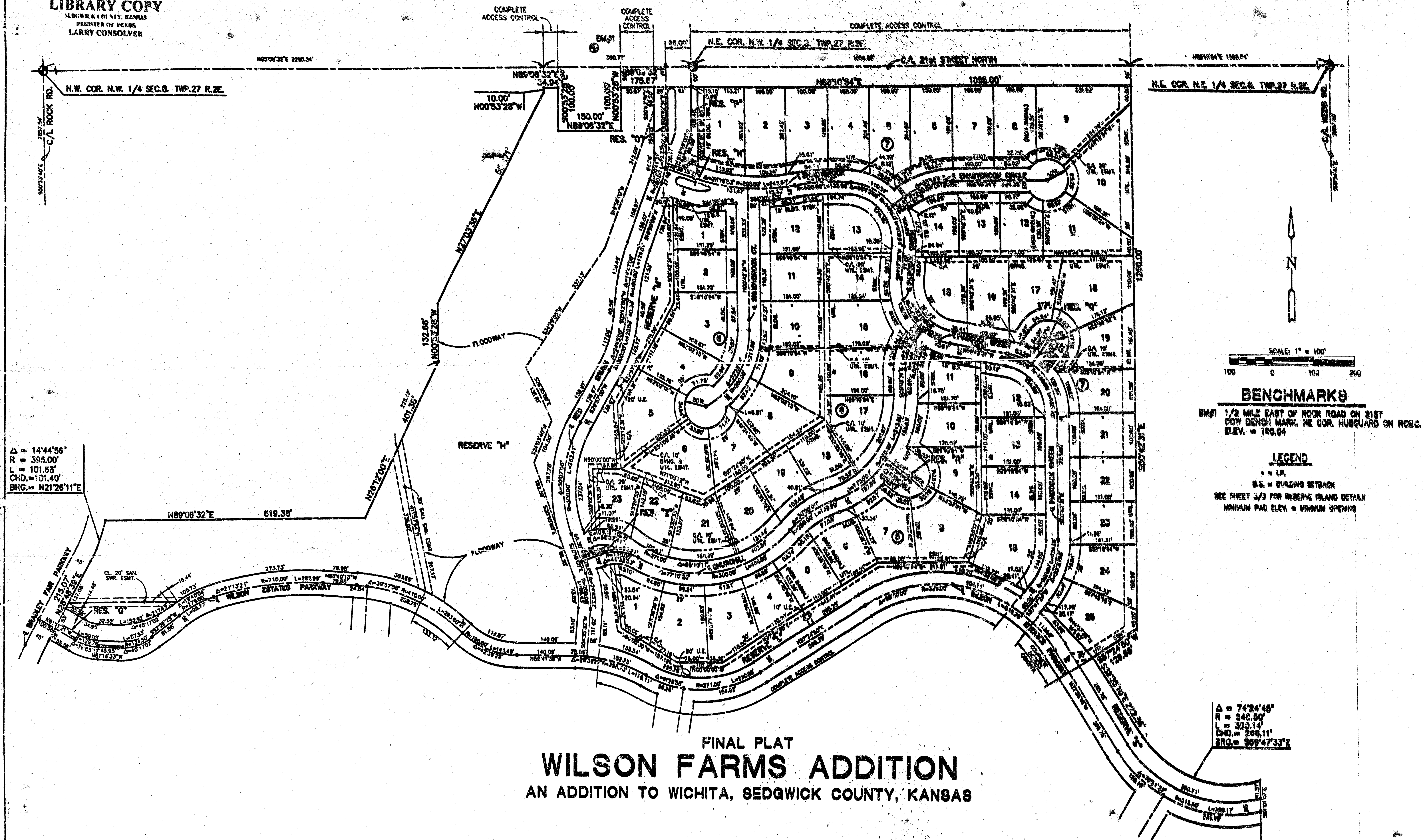

I, Kenneth H. Bangston, a Civil Engineer and Registered Land Surveyor in Kansas, do hereby certify that I have been in responsible charge of surveying and platting of WILSON FARMS ADDITION, an addition to Wichita, Sedgwick County, Kansas, into lots, blocks, streets, and reserves, the same being accurately set forth in the accompanying plat and description.

A tract of land lying in the Northeast and Northwest 1/4, Section 8, Township 27 South, Range 2 East of the 6th P.M., Sedgwick County, Kansas, more particularly described as follows:

Beginning at the Southeast corner of said Northwest Quarter; thence S 89° 18' 50" W, 1957.93 feet along the South line of said Northwest Quarter; thence N 00° 35' 40" W, 717.08 feet parallel with the West line of said Northwest Quarter to a point on the South right of way of Bradley Fair Parkway as platted in BRADLEY FAIR ADDITION, an addition to Wichita, Sedgwick County, Kansas, said point also on a curve to the left; thence along said curve and said Bradley Fair Parkway 524.00 feet, said curve having a central angle of 78° 00' 30", a radius of 380.00 feet, and a long chord of 583.45 feet, bearing N 48° 14' 02" E; thence continuing along said Bradley Fair Parkway; N 08° 43' 47" E, 94.63 feet to a point on a curve to the right; thence along said curve and said Bradley Fair Parkway 211.68 feet, said curve having a central angle of 22° 04' 52", a radius of 550.00 feet, and a long chord of 210.63 feet, bearing N 17° 40' 13" E; thence continuing along said Bradley Fair Parkway; N 28° 48' 38" E, 215.37 feet to a point on a curve to the left; thence along said curve and said Bradley Fair Parkway 101.68 feet, said curve having a central angle of 14° 44' 58", a radius of 395.00 feet, and a long chord of 101.40 feet, bearing N 21° 28' 11" E; thence N 89° 08' 32" E, 618.38 feet parallel with the North line of said Northwest Quarter; thence N 28° 12' 00" E, 401.35 feet; thence N 00° 53' 28" W, 132.68 feet; thence N 27° 03' 35" E, 554.71 feet; thence N 00° 53' 28" W, 100.00 feet to a point lying 50 feet South of the North line of said Northwest Quarter; thence N 89° 08' 32" E, 34.94 feet parallel with said North line; thence S 00° 53' 28" E, 100.00 feet; thence N 89° 08' 32" E, 150.00 feet; thence N 00° 53' 28" W, 100.00 feet to a point lying 50 feet South of the North line of said Northwest Quarter; thence N 89° 08' 32" E, 175.67 feet parallel with the North line and lying on the East line of said Northwest Quarter; thence N 89° 10' 54" E, 1055.00 feet parallel and 50 South of the North line of said Northwest Quarter; thence S 00° 42' 31" E, 1280.00 feet parallel with the West line of said Northwest Quarter; thence S 87° 24' 50" W, 126.66 feet; thence S 37° 35' 10" E, 222.56 feet to a point on a curve to the left; thence along said curve 320.14 feet, said curve having a central angle of 118° 11' 11", a radius of 320.14 feet, and a long chord of 298.11 feet, bearing S 65° 47' 33" E; thence S 01° 01' 47" E, 889.58 feet to a point lying on the South line of said Northwest Quarter; thence S 68° 58' 13" W, 1348.02 feet along said South line to the point of beginning.

The Sanitary Sewer Easement found on File 358 Page 380 and located within the described property is hereby vacated by virtue of K.S.A. 812(b).

Know all men by these presents that the undersigned property owners of the land as above set forth in the Civil Engineer's and Registered Land Surveyor's Certificate, have caused the same to be surveyed and platted into lots, blocks, streets and reserves, the same to be known as "WILSON FARMS ADDITION", an addition to Wichita, Sedgwick County, Kansas. The streets are hereby dedicated to and for the use of the public. Easements for the construction and maintenance of public utilities and drainage, are hereby granted to the public.

Reserves A through Z, inclusive are platted for open space, landscaping, lighting, and irrigation. Reserves C, E, G, I, K, N, Q, R, U, X, and Z are also platted for median and entry monuments. Reserve D is also platted for an access drive to Lot 18, Block 1. Reserves F, H, P, and Y are also platted for entry monuments. Reserves F, I, J, and Y are also platted for entry gates. Reserve H is also platted for floodway as indicated on the accompanying plat, gasbo's lakes and recreational activities. Reserves H, J, L, M, P, S, and V are also platted for walkways. Reserve Y is also platted for construction and maintenance of public drainage and lakes. Reserve Y is platted for private streets, drainage, utilities, entry monuments, and entry gates. The reserves shall be owned and maintained by the homeowners association.

The floodway as indicated on the accompanying plat shall be the responsibility of the owners until such time as the governing body exercising jurisdiction elects to assume the responsibility for the maintenance and improvements of the drainage, provided further, that no structure shall be constructed on or within said floodway, nor shall any fill, change of grade, creation of channel or other work be carried on without the permission of the City Engineer.

All egress right of access to or from 21st Street North over and across the North line of WILSON FARMS ADDITION, are hereby granted to the governing body. All egress right of access to or from Wilson Estates Parkway over and across the North lines of Reserves F, J, T, and V, over and across the South lines of Reserves H, L, and S are hereby granted to the governing body. The Emergency Access Easement located in Reserve S is hereby granted, to and for the use of the public and shall not be encumbered in any way except for a gate or other improvements as required by and approved by the City of Wichita Fire Department.

Minimum pad elevations (lowest opening) are as indicated on the accompanying plat.

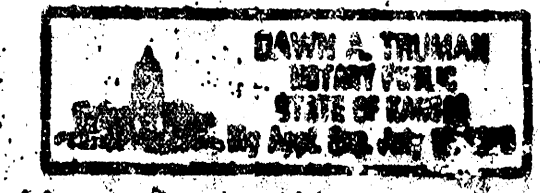

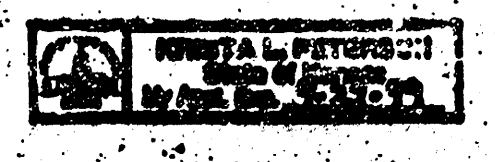
