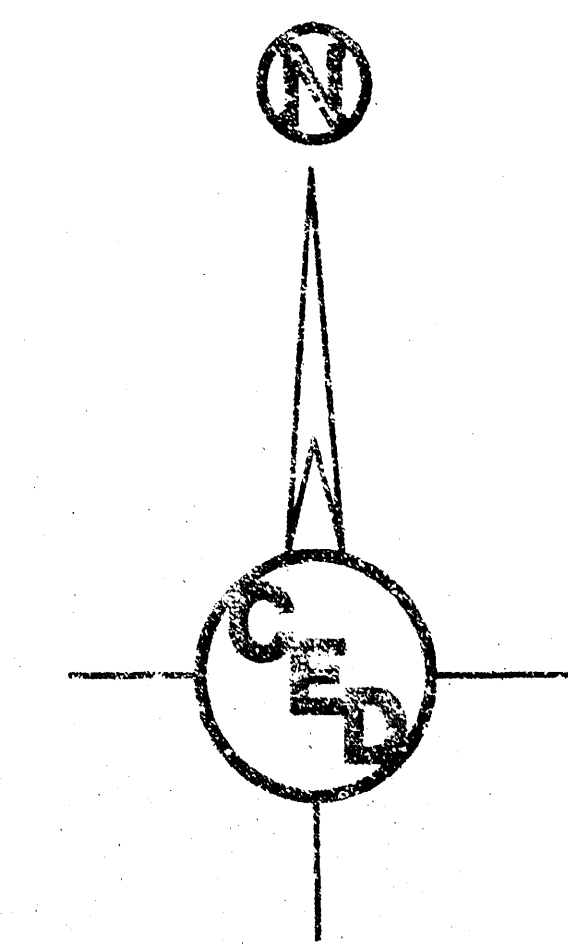
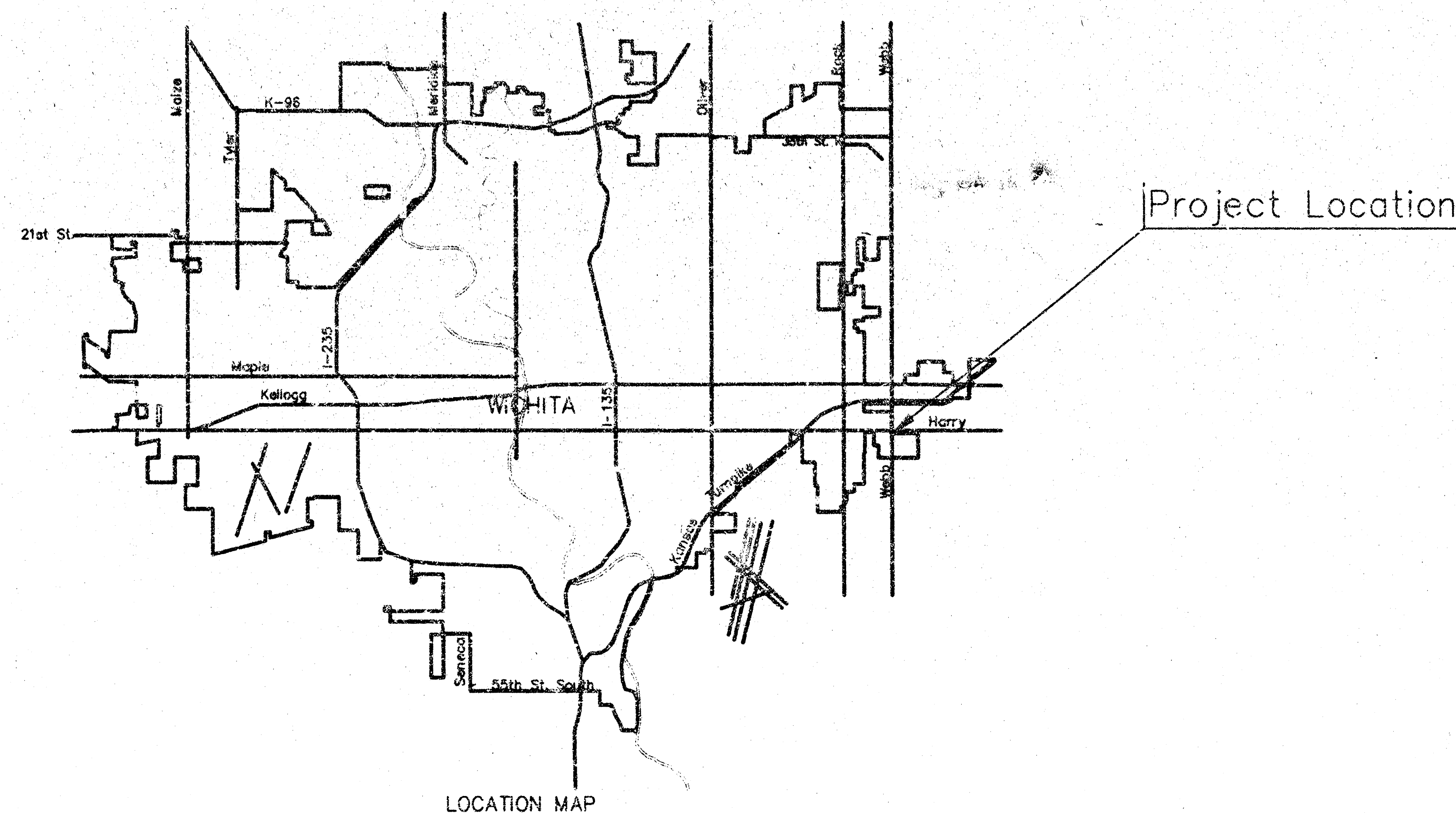

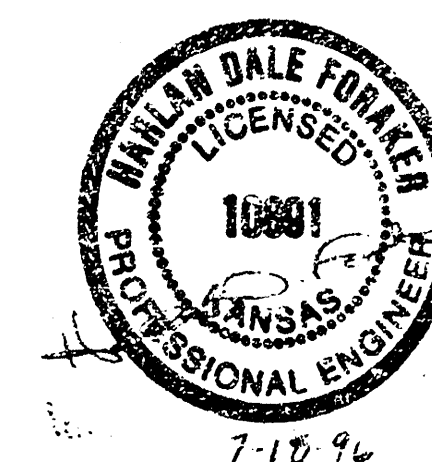
NOTE TO CONTRACTOR

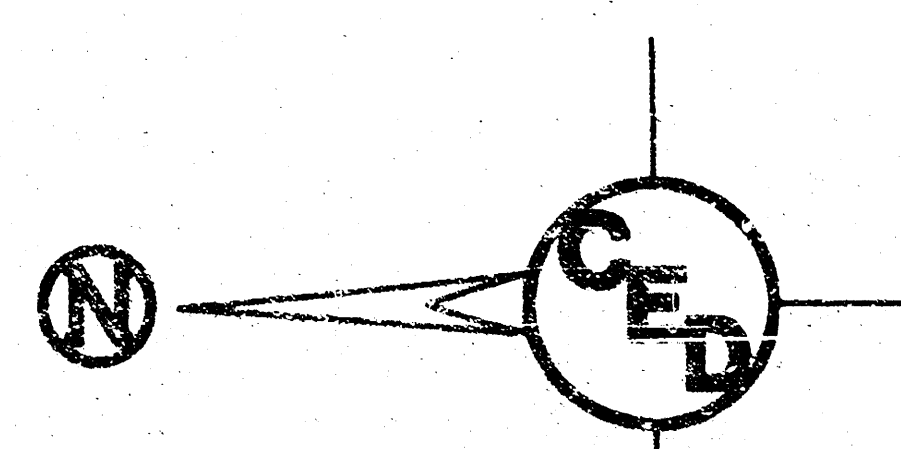

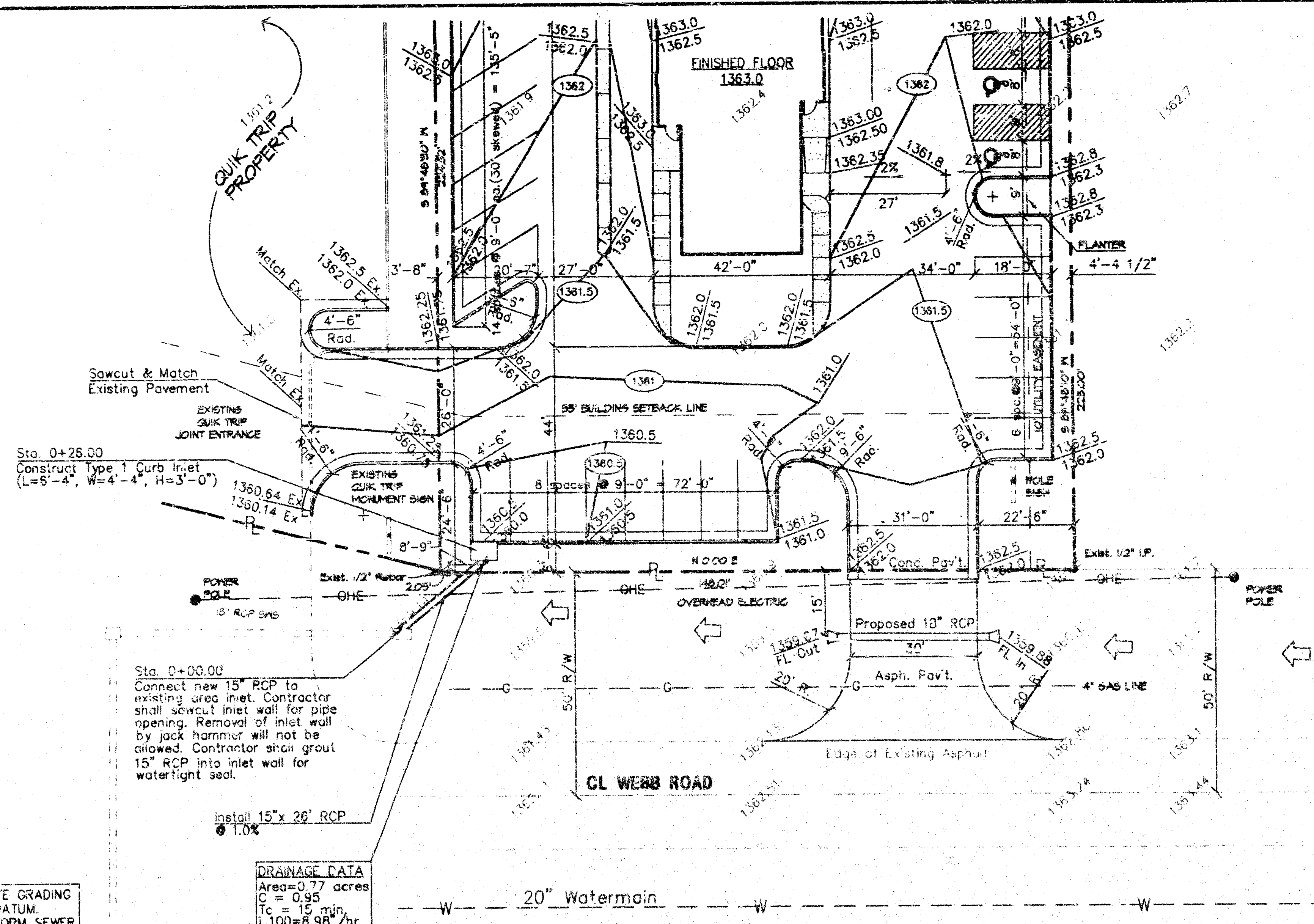

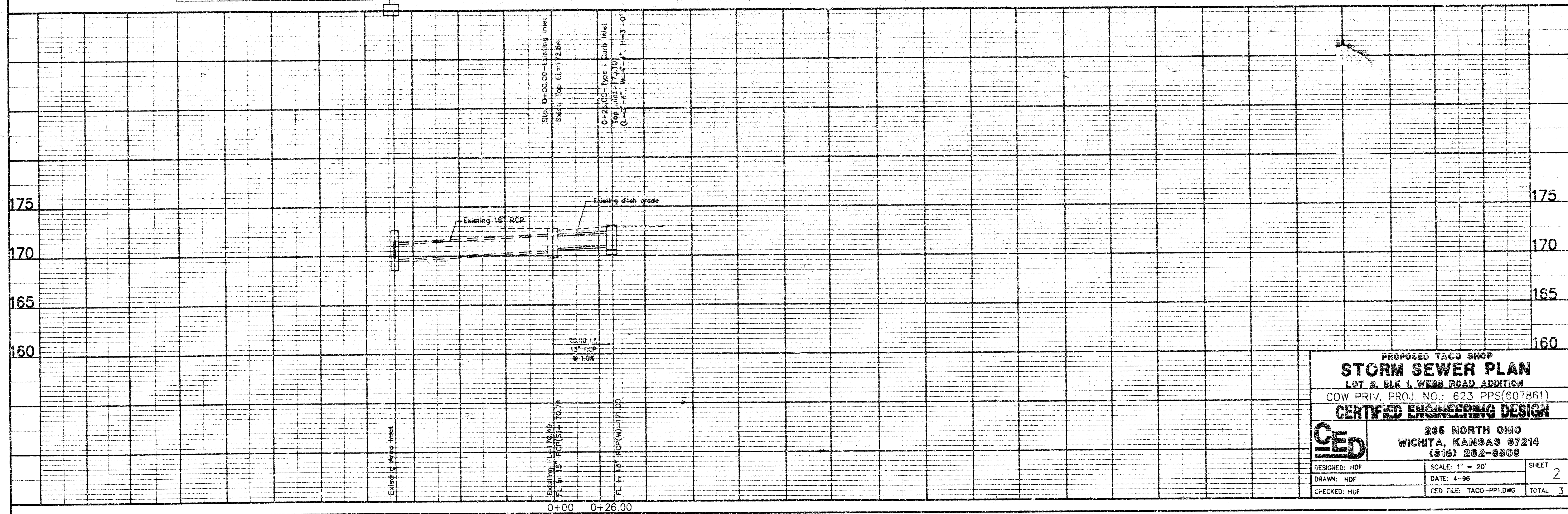

2. Pavement grades shown are to the top of pavement.
3. Existing elevations were provided by others.
Contractor shall verify existing grades and notify Engineer of any discrepancies.
4. Contractor shall be responsible for establishing and protecting Benchmark throughout construction.
5. Contractor shall strip site of topsoil (6" min.) and stockpile this material to be used in grassed areas.
6. Compaction of fill material and subgrade stabilization shall comply with Geotechnical Engineering Report.
7. The Contractor shall restore City right-of-way to conditions which existed prior to the commencement of work shown on this plan.

GENERAL NOTES

1. Concrete tops to be installed on this mortar cushion to insure full support along brick walls. Concrete tops may be cast in place or precast. Concrete used for inlet construction shall be concrete pavement mix.
2. Contractor shall have the option of constructing 8" brick masonry walls between the concrete inlet base and top on this inlet when W=6'-4" and H=7'-0" or less.
3. Inlet invert shall be shaped with 8 sack sand mix concrete to create flow channels and to increase hydraulic efficiency such that the inlet will be self cleaning between all inlet and/or outlet pipes.
4. The ends of all pipes installed in inlets shall be cut off flush with the inside face of the inlet wall.
