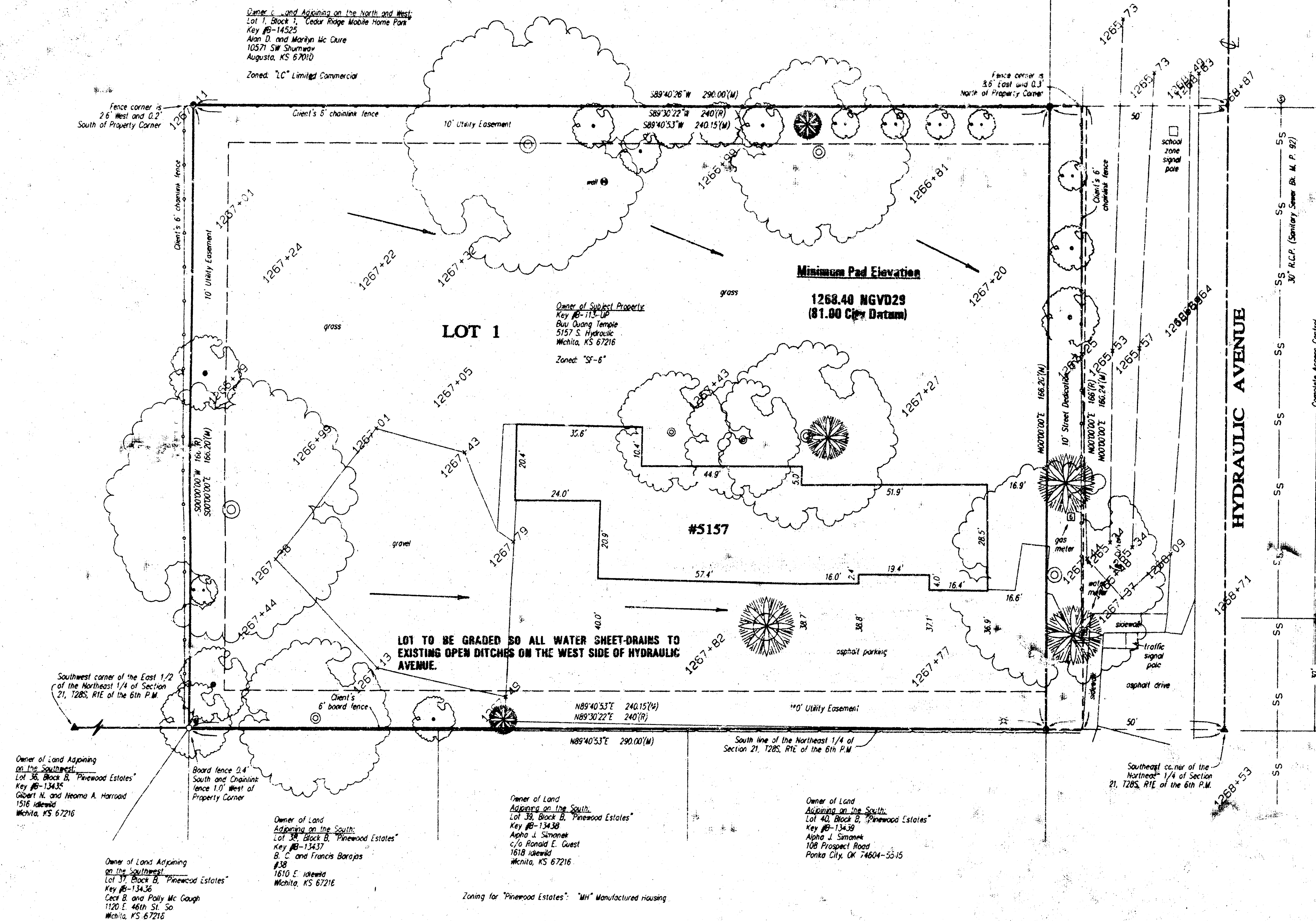


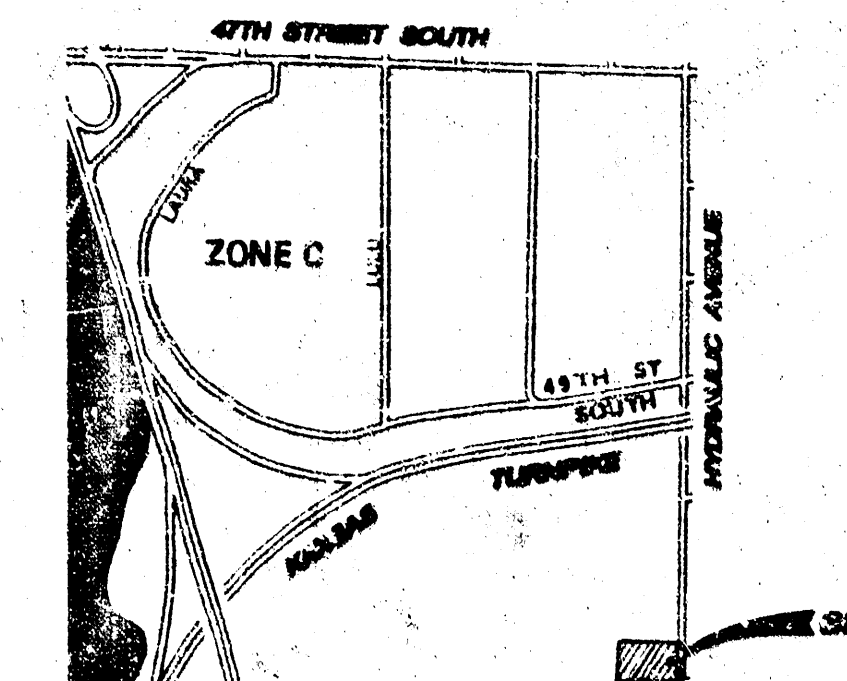
PRELIMINARY PLAT OF

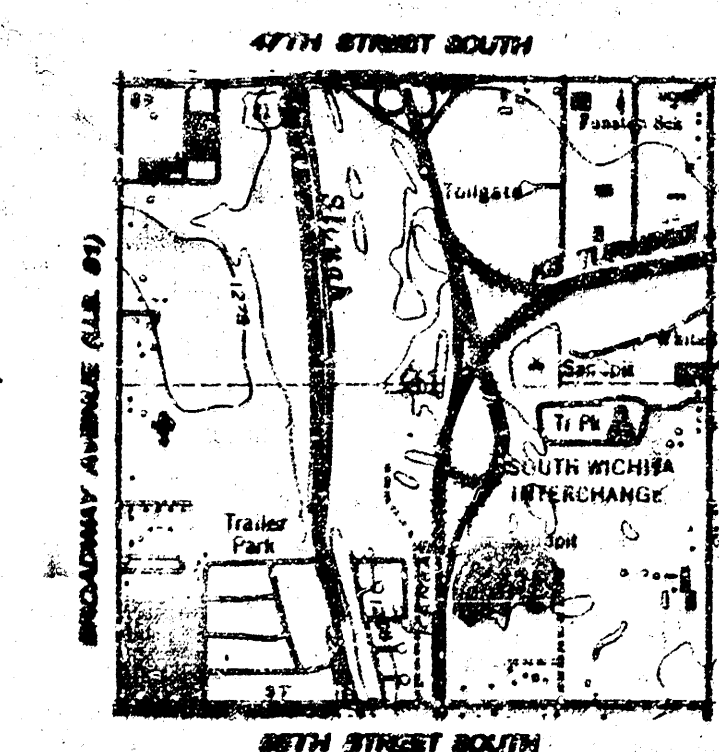

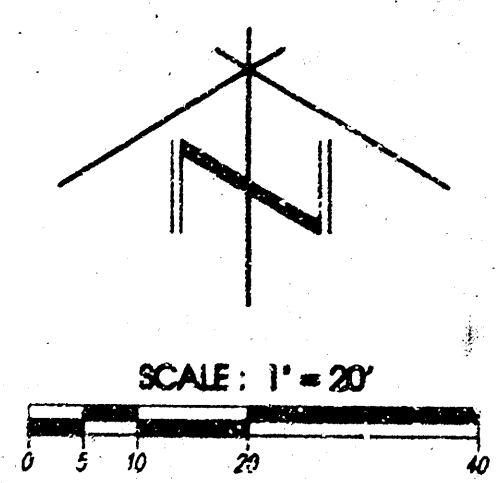


DERBY QUADRANGLE
