GENERAL NOTE

THE GEOLOGICAL INFORMATION SHOWN ON THESE PLANS
IS FROM STUDIES MADE IN THE FIELD AND REPRESENTS THE
BEST INFORMATION AVAILABLE TO THE KANSAS DEPARTMENT
OF TRANSPORTATION.

CHANNELS SHALL BE CUT AT BOX CULVERTS (UNLESS OTHERWISE NOTED) TO FLOW LINE ELEVATIONS AND TO A WIDTH OF ONE FOOT OUTSIDE OF EACH OUTSIDE WALL AND WITH SLOPES 2 TO 1 PRIOR TO CONSTRUCTION OF THE CULVERT.

EMBANKMENT QUANTITIES FOR INITIAL CONSOLIDATION AND SETTLEMENT SHOWN IN THE EARTHWORK QUANTITIES ARE SUBSIDIARY TO OTHER EARTHWORK ITEMS. MATERIAL FOR THE EMBANKMENT IS INCLUDED IN THE EXCAVATION QUANTITIES.

EXCAVATION SHOWN TO BE WASTED SHALL BE WASTED ON SITES PROVIDED BY THE CONTRACTOR. THESE SITES SHALL BE APPROVED BY THE ENGINEER AS TO SUITABILITY, APPEARANCE, AND SITE LOCATION. LOCATIONS THAT, IN THE OPINION OF THE ENGINEER, WILL LEAVE AN UNSIGHTLY APPEARANCE WILL NOT BE APPROVED.

CONNECTION OF EXISTING STORM SEWER PIPE TO NEW STRUCTURES OR EXISTING STRUCTURES TO NEW PIPE SHALL BE CONSIDERED SUBSIDIARY TO THE STORM SEWER BID ITEMS.

IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO COORDINATE WITH THE UTILITY OWNER TO LOCATE AND FLAG ALL UNDERGROUND UTILITIES PRIOR TO EXCAVATION TO AVOID DAMAGING THE UTILITIES. ALL KDOT OWNED UTILITIES ARE TO BE LOCATED BY THE CONTRACTOR. THE INFORMATION SHOWN IN THESE PLANS CONCERNING TYPE AND LOCATION OF UNDERGROUND UTILITIES IS NOT GUARANTEED TO BE ACCURATE OR ALL INCLUSIVE. THE CONTRACTOR IS RESPONSIBLE FOR MAKING HIS/HER OWN DETERMINATIONS AS TO THE TYPE AND LOCATION OF UNDERGROUND UTILITIES AS MAY BE NECESSARY TO AVOID DAMAGE THERETO.

THE FIELD SURVEY INFORMATION SHOWN ON THE DRAWINGS REPRESENTS THE EXISTING TOPOGRAPHIC CONDITIONS AS BEST AS COULD BE DETERMINED AT THE TIME OF THE SURVEY. DIFFERENCES IN THE VERTICAL AND HORIZONTAL CONTROL BETWEEN THE ORIGINAL GRADING/SURFACING PLANS AND THE NEW SURVEY COULD RESULT IN THE FIELD ADJUSTMENT OF TRANSITION LENGTHS AT LOCATIONS WHERE THE NEW CONSTRUCTION IS TO MATCH EXISTING FEATURES AND PROFILE GRADES.

ALL TREES, HEDGE ROWS, SHELTER BELTS, AND WOODY SHRUBS NOT SHOWN TO BE REMOVED AND LOCATED BETWEEN THE CONSTRUCTION LIMITS AND THE RIGHT-OF-WAY LINE OR EASEMENT LINE SHALL BE SPARED UNLESS DIRECTED BY THE ENGINEER TO BE REMOVED. ALL TREES WITHIN THE APPROPRIATE CLEAR ZONE SHALL BE REMOVED.

THE SANITARY SEWER LINES FOR PRIVATE PROPERTY SHALL BE MAINTAINED AT ALL TIMES OR ADEQUATE NOTIFICATION TO THE PROPERTY OWNER SHALL BE GIVEN FOR POSSIBLE INTERRUPTIONS. THESE CONNECTIONS MAY REQUIRE ADDITIONAL LENGTHS OF PIPE TO BE RESET, IT WILL BE THE CONTRACTOR'S RESPONSIBILITY FOR DETERMINING THIS EXTRA LENGTH. ALL WORK AND MATERIALS WILL BE SUBSIDIARY TO SANITARY SEWER WORK.

FOR SEQUENCE OF CONSTRUCTION AND TRAFFIC CONTROL GENERAL NOTES,
SEE SHEET NO. 60.

ALL EXISTING SIGNS, GUARD RAILS, CONCRETE PAVEMENT, ASPHALT AND OTHER ITEMS TO BE REMOVED SHALL BECOME THE PROPERTY OF THE CONTRACTOR, UNLESS OTHERWISE NOTED ON THE PLANS.

TEMPORARY SHORING AND/OR BRACING OF EXCAVATION SLOPES SHALL BE PROVIDED AS NECESSARY DURING CONSTRUCTION, BUT SHALL BE SUBSIDIARY TO OTHER ITEMS OF WORK.

IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO CLEAN DEBRIS (INCLUDING SOIL) FROM ROADWAY AS DIRECTED BY THE ENGINEER WITHIN 1 HOUR OF NOTICE. IF CONTRACTOR CAN NOT CLEAN WITHIN 1 HOUR, CITY CREWS WILL CLEAN UP DEBRIS AND BILL THE CONTRACTOR.
