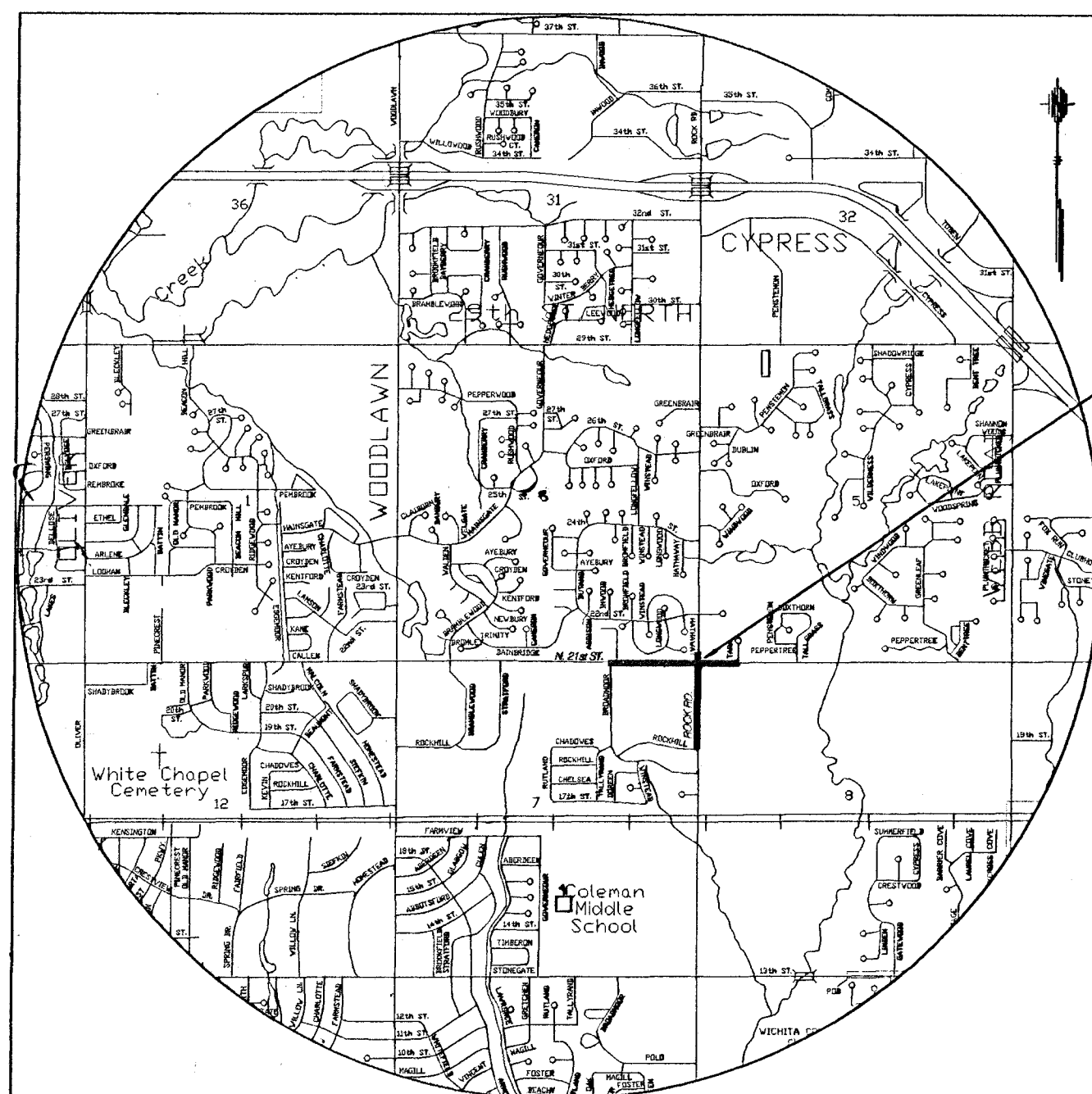

NO SCALE

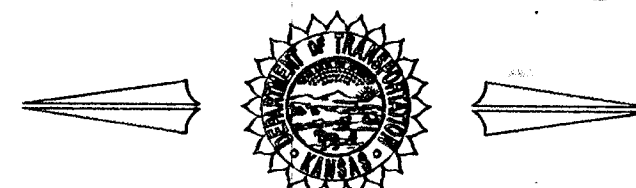

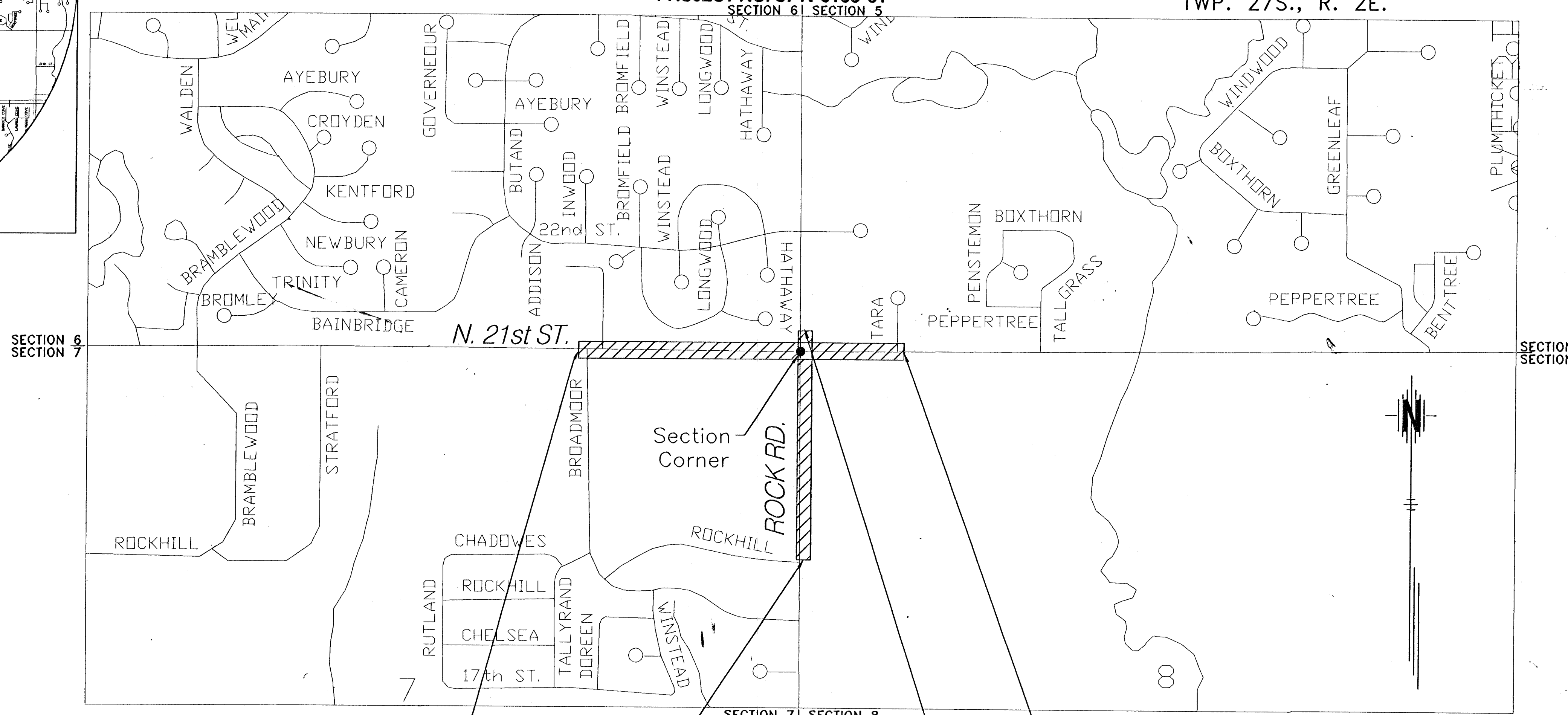
