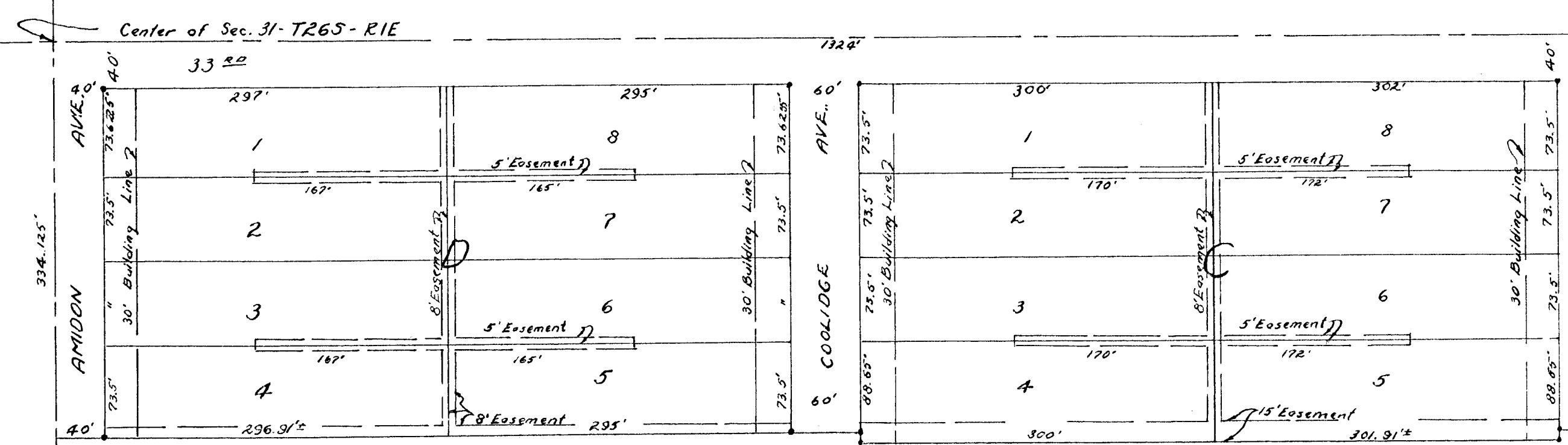


RIVERDALE ADDITION

Moehring, a Civil Engineer in and for said State and County, do hereby certify that I have surveyed and plotted RIVERDALE ADDITION, SEDGWICK COUNTY, KANSAS into Lots, Blocks, Avenues, Streets, a Road, and a Reserve. The same being accurately set forth in the accompanying plot and the same being described as follows: The Northeast Quarter of the Southeast Quarter of Section 31, Township 26 South, Range 1 East of the Sixth Principal Meridian; except beginning at a point 1343.5 feet North of the Southeast Corner of said Section 31; Thence West to a point 20 feet East of the Northwest Corner of the Southeast Quarter of the Southeast Quarter of said Section 31; Thence North 165 feet; Thence East to a point 165 feet North of the North line of the Southeast Quarter of the Southeast Quarter of said Section 31 and 875 feet West of the East line of Section 31; Thence Northeasterly to a point 615 feet North of the North line of the Southeast Quarter of the Southeast Quarter of Section 31 and 575 feet West of the East line of Section 31; Thence Northeasterly to a point on the East line of Section 31, 1000 feet North of the Northeast Corner of the Southeast Quarter of the Southeast Quarter of Section 31; Thence South to the point of beginning; and also except the North 20 feet and the West 20 feet of the Northeast Quarter of the Southeast Quarter of said Section 31 reserved for road purposes; owned by Lawrence J. Timmermeyer and Pauline M. Timmermeyer, his wife. Also the North One Half of Lots 4 & 5 Russell Tracts, Sedgwick County, Kansas owned by Benjamin W. Lawyer and Edna R. Lawyer, his wife.

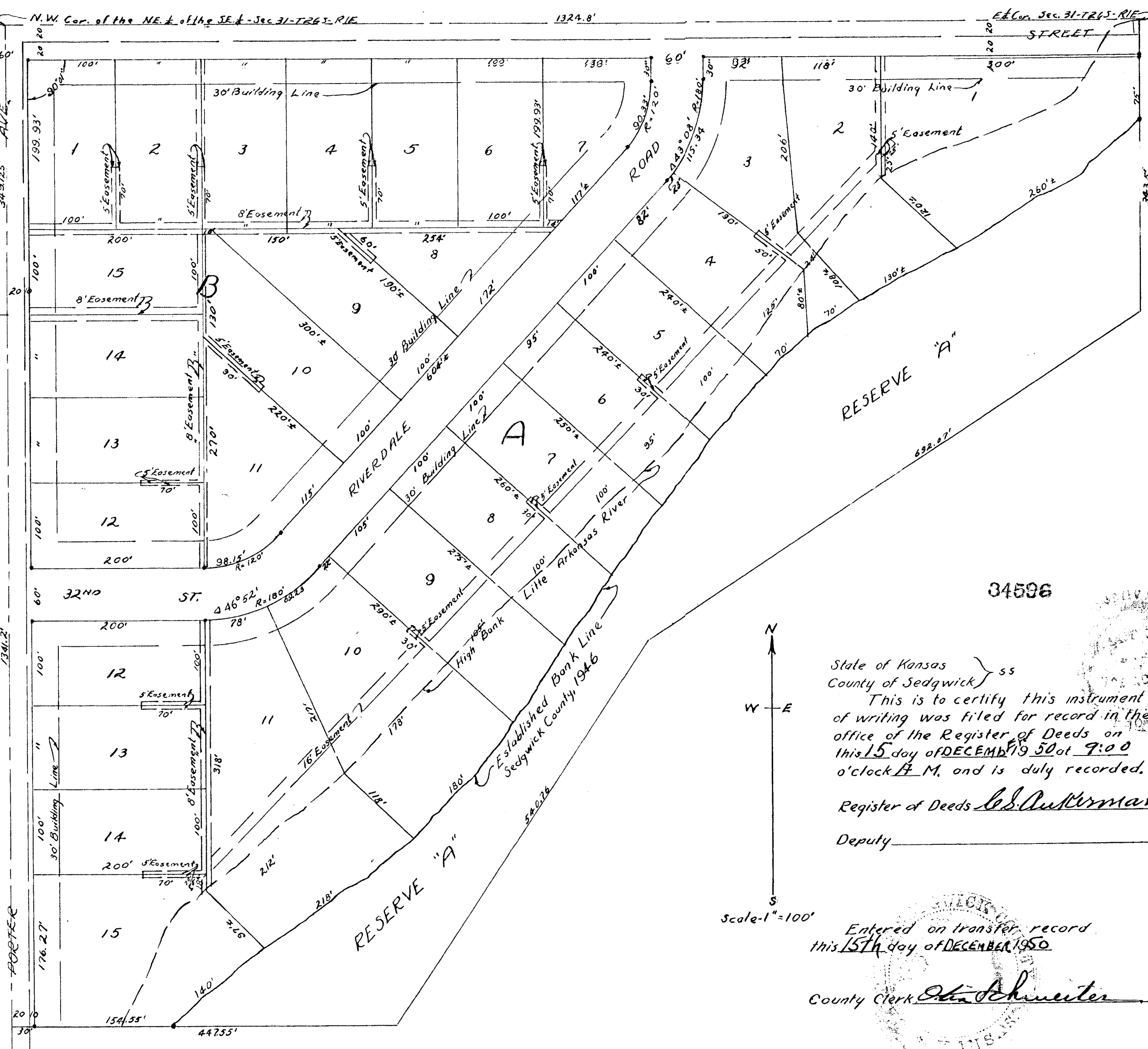
