I, Donald C. Armstrong, a Registered Land Surveyor in said state and county do hereby certify that on this 11th day of November, 2005, I have surveyed and plotted "BLUE SKY ADDITION" to Wichita, Sedgwick County, Kansas, into lots and blocks the same being the same described as follows:

LOT 9 ALONG WITH THE NORTH HALF OF VACATED 1ST STREET, BLOCK 10, PARKWILDE ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS EXCEPT THE EAST 135.0 FEET THEREOF, AND THAT PART OF LOTS 8 AND 10 ALONG WITH THE NORTH HALF OF VACATED 1ST STREET, BLOCK 10, PARKWILDE ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS DESCRIBED AS BEGINNING AT THE NORTHEAST CORNER OF SAID LOT 8; THENCE S07°02'53"E ALONG THE EAST LINE OF SAID LOTS 8 AND 10, 270.47 FEET TO A POINT ON THE CENTERLINE OF VACATED 1ST STREET; THENCE S89°00'09"W ALONG SAID CENTERLINE, 144.54 FEET TO A POINT 157 FEET EAST OF THE WEST LINE OF SAID LOTS 8 AND 10; THENCE N0°05'49"W PARALLEL WITH THE WEST LINE OF SAID LOTS 8 AND 10, 216.54 FEET; THENCE S89°02'04"W, 37.00 FEET; THENCE N0°05'49"W, 54.01 FEET TO THE NORTH LINE OF SAID LOT 8; THENCE N89°02'04"E ALONG SAID NORTH LINE, 181.77 FEET TO THE POINT OF BEGINNING.

Know all men by these presents that I, the undersigned, have caused the land described in the surveyors certificate to be plotted into lots and blocks to be known as "BLUE SKY ADDITION TO WICHITA, SEDGWICK COUNTY, KANSAS". The streets are hereby dedicated to and for the use of the public. The utility easements as indicated are hereby granted for the construction and maintenance of all public utilities. Reserve "A" is to be used as a detention pond. An owner's association shall be erected to own and maintain the Reserve. A drainage plan has been developed for this plat and all drainage easements, right-of-ways, or reserves shall remain at established grades or as modified with approval of the applicable city or county Engineer, and unobstructed to allow for the conveyance of stormwater. Minimum pad elevations shall be as indicated above.

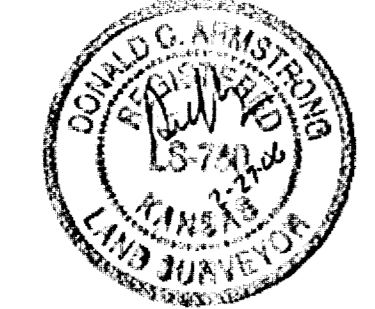

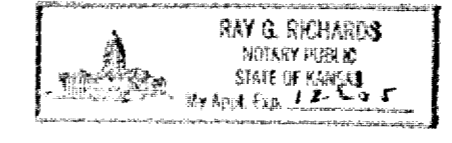
