RE: BZA2016-00047: City Sign Code Adjustment to increase square footage of a wall sign on property zoned GC General Commercial and B Multi-Family Residential with sign located in GC.

Legal Description: LOTS 1 & 2 EXCEPT CANAL, BAKER'S ADDITION, WICHITA, SEDGWICK COUNTY, KANSAS. Generally located south of Central and east of Kansas (440 N. Kansas)

Dear Applicants:

We have reviewed your request for a Sign Code Adjustment to permit a 194.33 square foot wall sign. From reviewing your application, we understand that you propose to install a new wall sign for Spiker Heating and Air at 440 N. Kansas which will be visible from south bound I-135.

Section 24.04.251.2.c. of the Sign Code allows an adjustment to increase the maximum allowed size of individual building or wall signs or of the total allowed building sign wall elevation coverage by up to twenty percent; when the three conditions required by Section 24.04.251.6 of the Sign Code are met. We find that allowing the sign as proposed meets the three conditions required by Section 24.04.251.6 of the Sign Code as set out below:

- 1) Impact on existing uses in surrounding areas: Existing uses in the surrounding area are B Multi-Family Residential to the south; GC General Commercial to the north and west; and I-135 right-of-way to the east.
- 2) Compatibility with existing or permitted uses on abutting sites: The sign will be oriented to I-135 and East Central Avenue, signage does not face any residential uses.

- 3) Effect on public health, safety or welfare: There will be no encroachment into public right-of-way; there should be no impact on the public health, safety or welfare, nor will properties or improvements in the vicinity be materially injured.

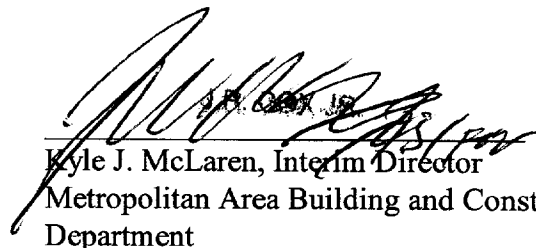
Our signatures below indicate that a Sign Code Adjustment to increase the size of the proposed sign to 194.33 square feet is **GRANTED**, subject to the following conditions:

- 1) The Administrative Adjustment is to allow a 194.33 square foot wall sign; all signage on the site shall otherwise conform to the Sign Code unless a separate adjustment or variance is approved.
- 2) The sign shall be in conformance with the approved elevation and site plan. The sign shall be permitted and installed within one year from the date of approval.
- 3) If the Zoning Administrator finds that there is a violation of any of the conditions of the Sign Adjustment, the Zoning Administrator, in addition to enforcing the other remedies set forth in the Sign Code, may, with the concurrence of the Planning Director, declare that the Sign Adjustment is null and void.

The development application sign should now be removed from the property.

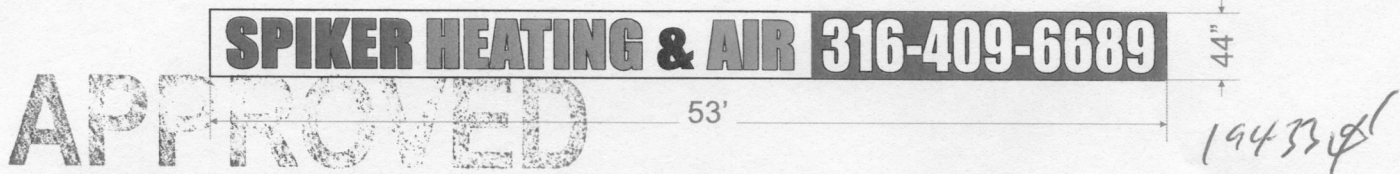
