SUBJECT: Z-2891 ZONE CHANGE FROM THE "B" MULTIPLE FAMILY DWELLING DISTRICT TO THE "C" COMMERCIAL DISTRICT. GENERALLY LOCATED AT THE SOUTHEAST CORNER OF 13TH AND MARKET. (District #1)

MAPC Recommendation: Deny "C"; reapprove "LC" (8-0)

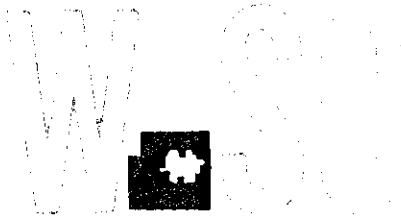
Staff Recommendation: Deny "C"; reapprove "LC"

CPO Recommendation: Council "1A" considered this request on January 19, 1988. The Council voted 4-2 to approve "LC" subject to two of the three houses on the property being moved to acceptable locations within the Midtown Neighborhood.

Background: On March 17, 1988, the MAPC held a public hearing to reconsider a zone change from "B" to "C" for a 0.3-acre site consisting of three narrow platted lots containing three houses at the southeast corner of 13th and Market. They had previously reviewed this application on January 21st and had recommended approval of "LC" zoning. The Council returned the case for rehearing after questions were raised about a possible policy against additional commercial zoning on north Market and about the Midtown Citizens Association's opinions on this zoning change. It was determined there is no official policy regarding zoning on north Market although there is a 1975 policy establishing the north and east boundaries of commercial zoning near the 9th and Main intersection. A representative of the MCA spoke at the March 17 meeting in support of the rezoning to "LC".

- Recommendations/Actions:
1. Concur with the findings of the MAPC and approve the zone change subject to the condition of platting; instruct the Planning Department to forward the ordinance for first reading when the plat is forwarded to the City Council; or
  2. Take appropriate action stating reasons.
