SUBJECT: Z-2961 - ZONE CHANGE FROM THE "A" TWO-FAMILY DWELLING
DISTRICT TO THE "BB" OFFICE DISTRICT (AS AMENDED), LOCATED
ON THE WEST SIDE OF HILLSIDE BETWEEN GILBERT AND ORME.
(District #3)

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

MAPC Recommendation: Approve, (9-0).

Staff Recommendation: Approve, subject to property being replatted
into not more than two lots.

CPO Recommendation: CPO Council "3A" voted 8-0 to recommend
approval.

Background: On August 29, 1989, the City Council considered a zone
change request for "BB" zoning for a portion of the current
application area. At this meeting the council voted 7-0 to return the
case to the Planning Commission. This action was based on a request
by the applicant's attorney.

On November 20, 1989, the MAPC reconsidered this case which had been
amended to include a larger application area. When the MAPC first
considered this case on August 3, 1989, the application area only
involved two 25-foot-wide platted lots. After the City Council
returned the case to the MAPC, the application area was enlarged to
encompass six lots on the west side of Hillside between Gilbert and
Orme.

The original applicant for this case owns the south 50 feet of the
site. If this case is approved, this property owner plans to use his
property for a psychologist's office. The two owners of the north 100
feet of the application area have no immediate plans for their prop-
erty; however, in the future they plan to redevelop their property
with a general office use.

RECOMMENDATIONS/ACTIONS:

1. Concur with the findings of the MAPC and approve the zone change, subject to the condition of platting; instruct the Planning Department to forward the ordinance for first reading when the plat is forwarded to the City Council.
2. Take appropriate action stating reasons.

ORDINANCE NO. 41-328

AN ORDINANCE CHANGING THE ZONING CLASSIFICATIONS OR DISTRICTS OF CERTAIN LANDS LOCATED IN THE CITY OF WICHITA, KANSAS, UNDER THE AUTHORITY GRANTED BY SECTION 28.04.210, THE CODE OF THE CITY OF WICHITA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY
OF THE CITY OF WICHITA, KANSAS.

SECTION 1. That having received a recommendation from the Planning Commission, and proper notice having been given and hearing held as provided by law and under authority and subject to the provisions of Section 28.04.210, The Code of the City of Wichita, Kansas, the zoning classification or districts of the lands legally described hereby are changed as follows:

Case No. Z-2961

Zone change from the "A" Two-Family Dwelling District to the "BB" Office District.

Lot 1, Schuyler Addition to Wichita, Sedgwick County, Kansas.

Located west of Hillside in an area south of Kellogg.

SECTION 2. That upon the taking effect of the Ordinance, the above zoning change shall be entered and shown on the "Official Zoning Map" previously adopted by reference, and said official zoning map is hereby reincorporated as a part of the Zoning Ordinance as amended.
