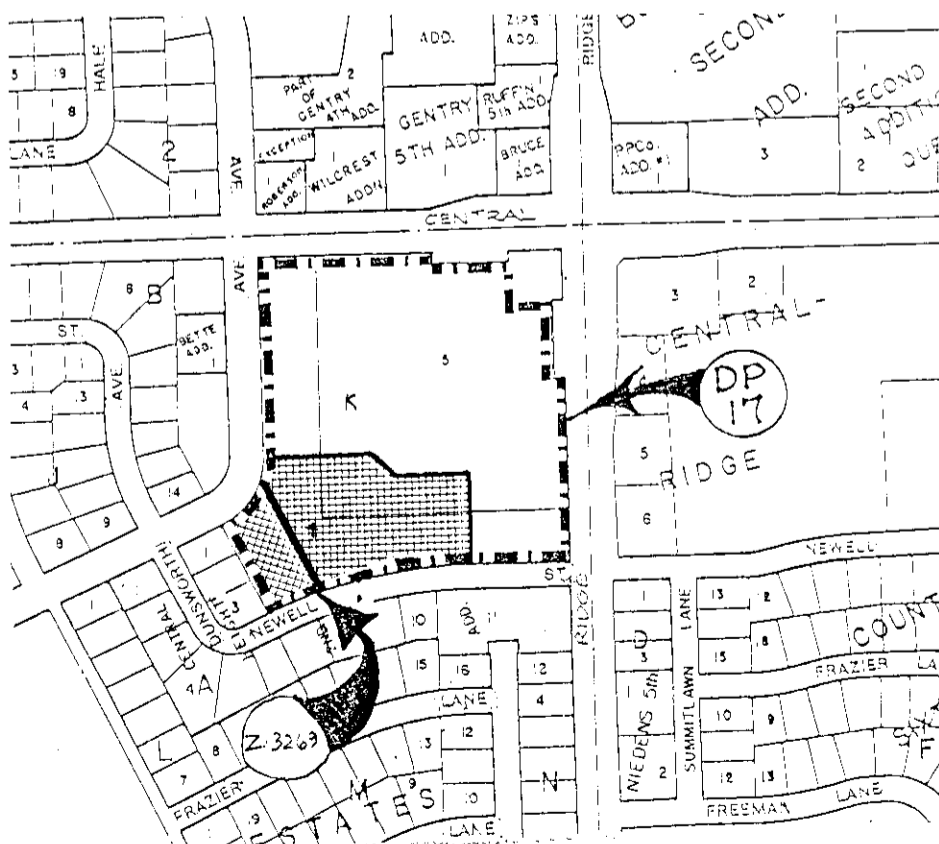

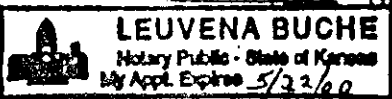

ORDINANCE NO. 43-773

AN ORDINANCE CHANGING THE ZON-
ING CLASSIFICATIONS OR DISTRICTS
OF CERTAIN LANDS LOCATED IN THE
CITY OF WICHITA, KANSAS, UNDER
THE AUTHORITY GRANTED BY THE
WICHITA-SEDGWICK COUNTY UNIFIED
ZONING CODE, SECTION V-C, AS
ADOPTED BY CITY OF WICHITA CODE
SEC. 28.04.010.

BE IT ORDAINED BY THE GOVERNING
BODY OF THE CITY OF WICHITA,

KANSAS.

SECTION 1. That having received a rec-
ommendation from the Planning
Commission, and proper notice having been
given and hearing held as provided by law
and under authority and subject to the pro-
visions of The Wichita-Sedgwick County
Unified Zoning Code, Section V-C, as adopt-
ed by City of Wichita Code Sec 28.04.010,
the zoning classification or districts of the
lands legally described hereby are changed
as follows:

Case No. Z-3269

Zone change request from "LC" Limited
Commercial and "GC" General Commercial
District to "GC" General Commercial Dis-
trict, described as:

The southwestern 175 feet of Lot 4, Block K,
Meadowview Estates, an addition in Sedg-
wick County, Kansas. Generally located
west of Ridge Road and north of Newell.

SECTION 2. That upon the taking effect
of this ordinance, the above zoning changes
shall be entered and shown on the "Official
Zoning Map" previously adopted by refer-
ence, and said official zoning map is hereby
reincorporated as a part of the Wichita -
Sedgwick County Unified Zoning Code as
amended.

SECTION 3. That this Ordinance shall
take effect and be in force from and after its
adoption and publication in the official City
paper.
