

THIS EASEMENT made this 22nd day of April,

public utilities.

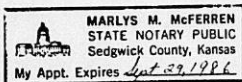


