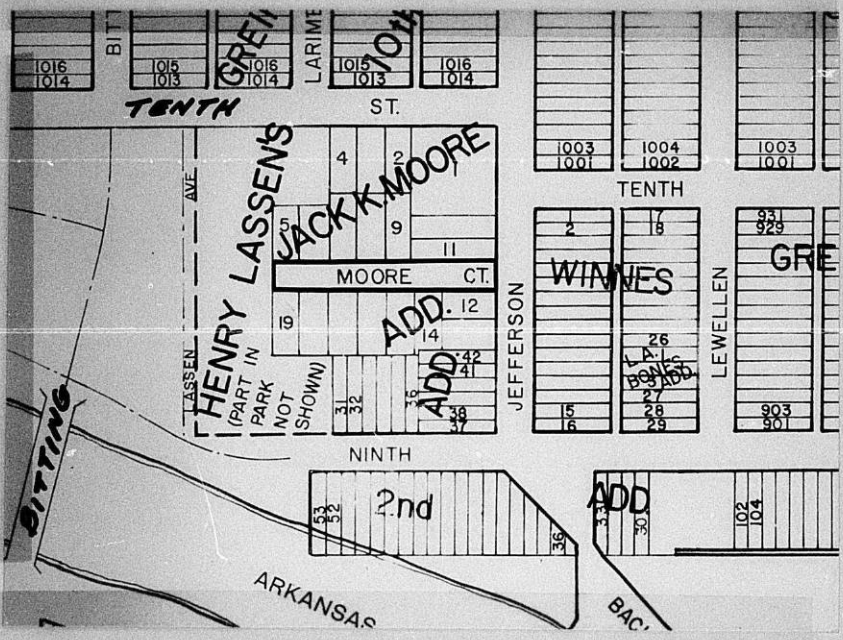

ORDINANCE NO. _____

AN ORDINANCE CHANGING THE NAME OF A CERTAIN STREET IN THE CITY OF WICHITA, AND REPEALING ALL ORDINANCES AND OR PARTS THEREOF WHICH ARE IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS.

SECTION I. That it is hereby declared to be in the interest and convenience of the public to eliminate confusion in the name of the following named street in the City of Wichita, and the name of such street should be, and the same is hereby, changed from and after the effective date of this ordinance, and shall be known, named, and designated by the new name as follows, to-wit:

MOORE COURT or PIPPIN COURT, one block in length, extending west from Jefferson in an area between 9th and 10th Streets, be changed to PIPPIN CIRCLE.

SECTION II. That all ordinances or parts thereof which are in conflict with this ordinance are hereby repealed.

SECTION III. That this ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

Description of Street Affected:

Moore Court as platted in Jack K. Moore Addition.

Reason for Change:

On December 2, 1935, Moore Court was vacated by City Ordinance No. 11-546. Since this time, the private drive became known as Pippin Court and street signs were placed at the intersection of the private drive and Jefferson Avenue.

On March 24, 1972, the City of Wichita obtained the necessary dedications and reopened the street by Ordinance No. 32-097. This Ordinance did not establish an official street name.

It is recommended that the street be officially named Pippin Circle, due to the east and west numbering system that has been in effect for sometime, and it is not a through street.
