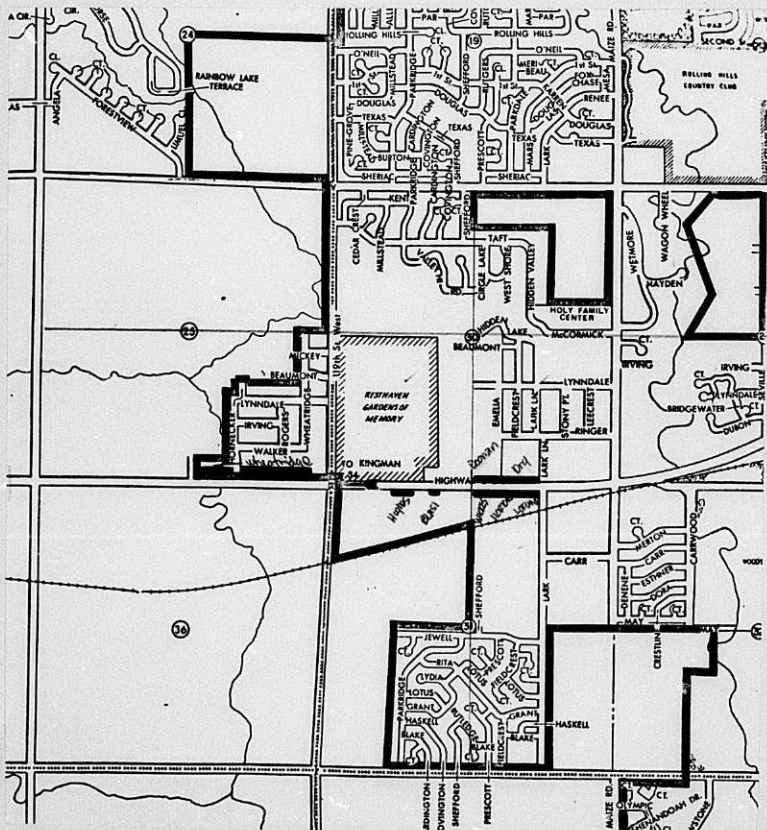

ORDINANCE NO. 38-826

AN ORDINANCE CHANGING THE STREET NAME OF HARRY DRIVE AS PLATTED IN J. ROBERT DRY ADDITION, DOONAN PLAZA II ADDITION, WHEATRIDGE ADDITION, LOFLAND ADDITION, HORTON ADDITION, WICKES ADDITION, BLASI PARK ADDITION AND HUGHES ADDITION; ALL ADDITIONS TO SEDGWICK COUNTY, KANSAS; TO KELLOGG DRIVE AND REPEALING ALL ORDINANCES OR PARTS THEREOF WHICH ARE IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF WICHITA, KANSAS:

SECTION 1. That it is hereby declared to be in the interest and convenience of the public to eliminate confusion in the name of the following described street within the City limits of the City of Wichita and the name of such street should be, and the same is hereby changed from and after the effective date of this ordinance, and shall be known, named and designated by the new name as follows, to-wit:

Harry Drive as platted in J. Robert Dry Addition, Doonan Plaza II Addition, Wheatridge Addition, Lofland Addition, Horton Addition, Wickes Addition, Blasi Park Addition and Hughes Addition; all additions to Sedgwick County, Kansas; be changed to Kellogg Drive.

SECTION 2. That all ordinances or parts thereof which are in conflict with this resolution are hereby repealed.

SECTION 3. That this ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.

Dear Property Owners:

Within the past twenty years, several subdivision plats along West Kellogg (U.S. Highway 54) have been recorded with the name "Harry Drive" being shown for the frontage road. Most plats, however, show "Kellogg Drive" as the name for the frontage road both on the north and the south sides of the highway. A check of the City and suburban directories and the telephone book reveals that most addresses are either "West Kellogg" or "West Highway 54."

In order to avoid confusion in the official naming of streets and to prevent future addresses being assigned with a Harry Drive designation, the Metropolitan Area Planning Department requests that Kellogg Drive be recognized as the official name for the frontage roads on both sides of Kellogg (U.S. Highway 54). The Subdivision Committee of the Metropolitan Area Planning Commission will consider this request at their meeting on Thursday, May 24, 1984. Their meeting will be held in the Board Room on first floor of City Hall, 455 North Main, beginning at 1 p.m. This matter will be item 7 on the agenda.

Those of you receiving a copy of this letter are owners of lots within the subdivisions which were platted with Harry Drive as the name of the frontage road. Unless you are now using a "West Harry Drive" address for your property, no address change will be necessary. However, you may express your opinion on this proposal to officially change the frontage road name from Harry Drive to Kellogg Drive by either attending the May 24th meeting or calling me at 268-4421. You may also write to the Planning Commission at the address shown above.

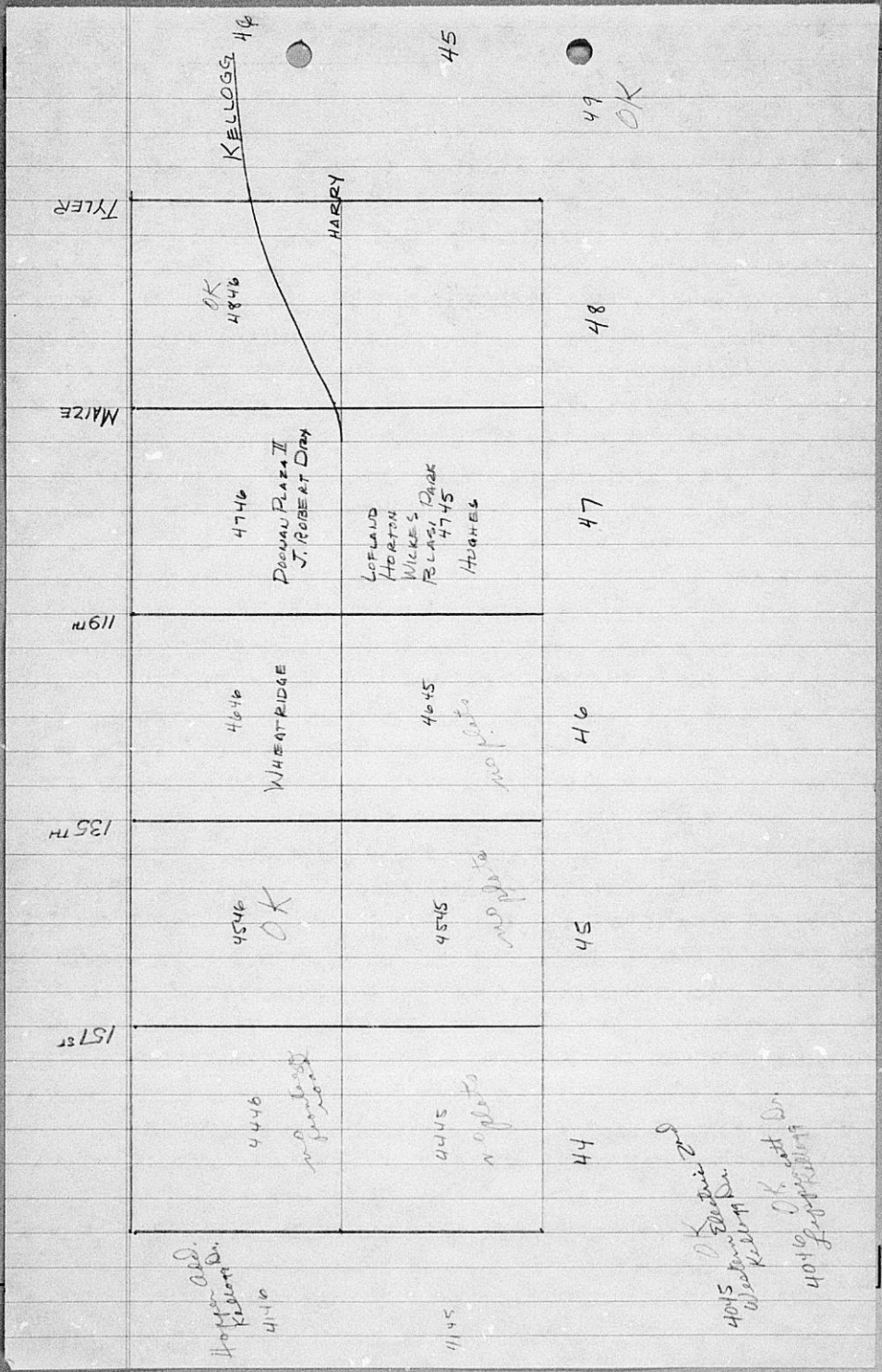

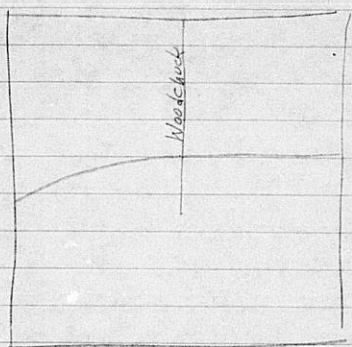

SUBJECT Official street name for U.S. 54 highway and frontage roads

Tim Cain has asked for the Planning Department to determine what is the official name of U.S. 54 and its frontage road in the newly annexed areas on the west side of town. City street signs need to be installed and there is a question of whether "U.S. 54 Highway", "Kellogg", or even "Harry" is the correct name between Maize and 119th Street West. I have checked most of the plats in the area and the majority of them have "U.S. 54 Highway" as the name of the major road and "Harry Drive" as the name of the frontage road. However, I don't know of any businesses with a Harry Drive address. It would appear from the city and suburban directories and the telephone book that most addresses west of Tyler are "West Highway 54". A few are "West Kellogg."

I believe that U.S. 54 Highway is a proper designation for the road from county line to county line as far as the state and federal highway departments are concerned. But because the route of the highways may change (as did K-96), I believe it to be proper for a name to be assigned to a numbered highway as platting occurs adjacent to the highway. I would recommend that "Kellogg" be recognized as the official name of U.S. 54 Highway and "Kellogg Drive" be recognized as the official name of the frontage roads on both sides of the highway. These designations also to be from county line to county line. The name "Harry Drive" should be applied to only those frontage roads adjacent to Harry east of Maize Road. *agrd*

Please let me know your thoughts on this matter as Engineering is anxious to order the street signs as soon as possible.


SUBJECT Street Names & Addresses
Recently Annexed West Area

As a part of our work of establishing address records and review of street signs in the recently annexed areas of west Wichita, addresses in use for two cul-de-sac streets were noticed to be different from those in the quarter section plat records of the County Clerk's office. Attached is a map of the area. The cul-de-sac labeled as Elizabeth Ct. is currently posted with the street name sign of Wagon Wheel, and Polk's Suburban Directory indicates that Wagon Wheel addresses are being used. The street appears as Wagon Wheel on the City map.

The cul-de-sac labeled as Hayden Ct. is currently posted with the street name sign of Wetmore Ct., and Polk's Suburban Directory indicates that Wetmore Ct. addresses are being used. The street appears as Hayden on the City map.

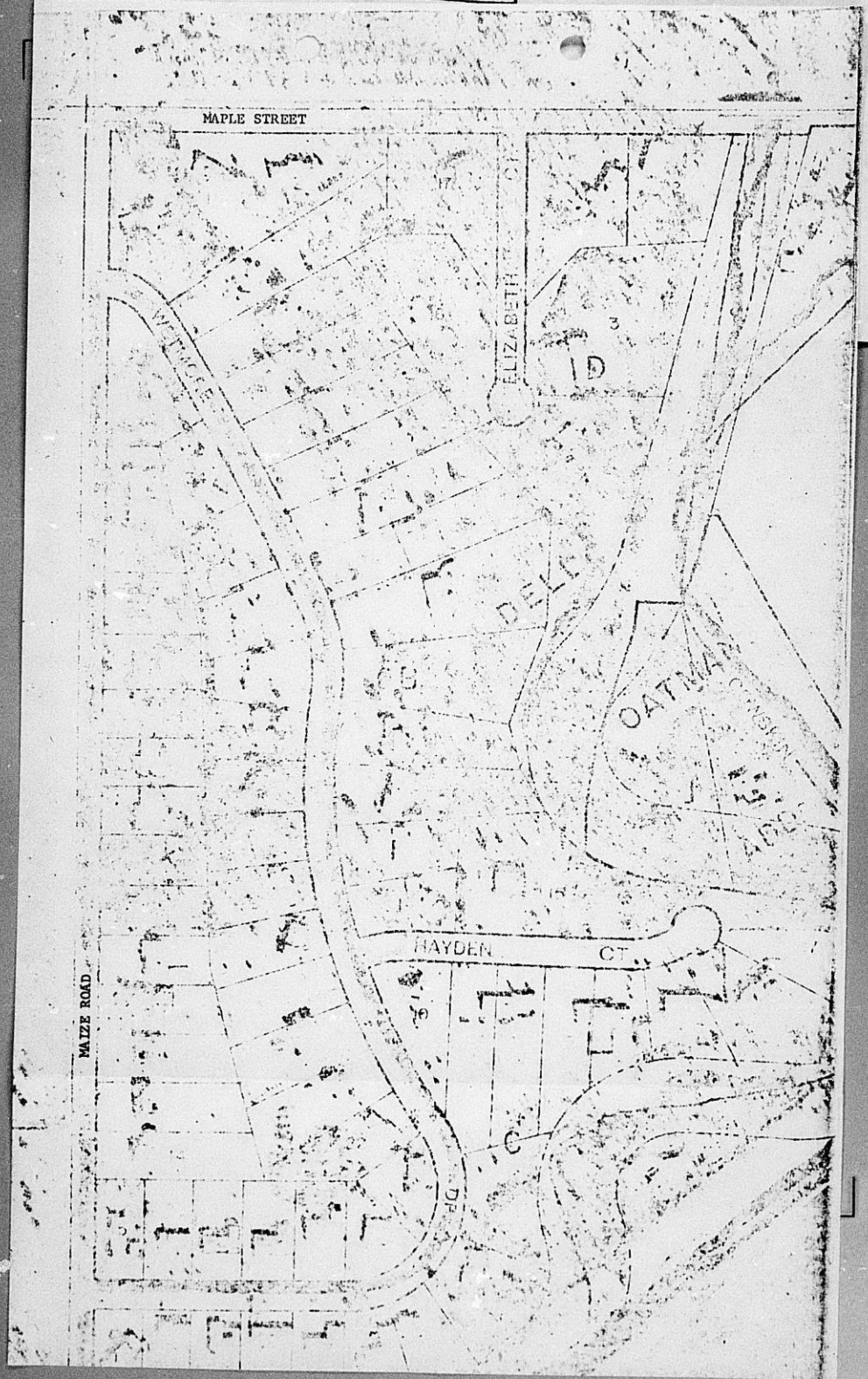
A study conducted by the Metropolitan Area Planning Department in 1957 and 1958 recommended that the streets be changed from Elizabeth Court to Wagon Wheel and from Hayden Court to Wetmore Court, but records do not indicate that formal action was ever taken by the County Commission to make the changes.

It is recommended that formal action by resolution or ordinance be taken on the City Clerk's Agenda to approve street name changes as previously recommended by the Planning Department and as the addresses are currently being used. This is merely a clarifying action and is recommended to eliminate possible confusion in a notification process. Legal actions involved with annexations in this area may also be a factor in proceeding on this matter.

Dear Property Owners:

Within the past twenty years, several subdivision plats along West Kellogg (U.S. Highway 54) have been recorded with the name "Harry Drive" being shown for the frontage road. Most plats, however, show "Kellogg Drive" as the name for the frontage road both on the north and the south sides of the highway. A check of the City and suburban directories and the telephone book reveals that most addresses are either "West Kellogg" or "West Highway 54."

In order to avoid confusion in the official naming of streets and to prevent future addresses being assigned with a Harry Drive designation, the Metropolitan Area Planning Department requests that Kellogg Drive be recognized as the official name for the frontage roads on both sides of Kellogg (U.S. Highway 54). The Subdivision Committee of the Metropolitan Area Planning Commission will consider this request at their meeting on Thursday, May 24, 1984. Their meeting will be held in the Board Room on first floor of City Hall, 455 North Main, beginning at 1 p.m. This matter will be item 7 on the agenda.

Those of you receiving a copy of this letter are owners of lots within the subdivisions which were platted with Harry Drive as the name of the frontage road. Unless you are now using a "West Harry Drive" address for your property, no address change will be necessary. However, you may express your opinion on this proposal to officially change the frontage road name from Harry Drive to Kellogg Drive by either attending the May 24th meeting or calling me at 268-4421. You may also write to the Planning Commission at the address shown above.

If you lease your property to someone, please inform them of this proposed street name change and meeting date.

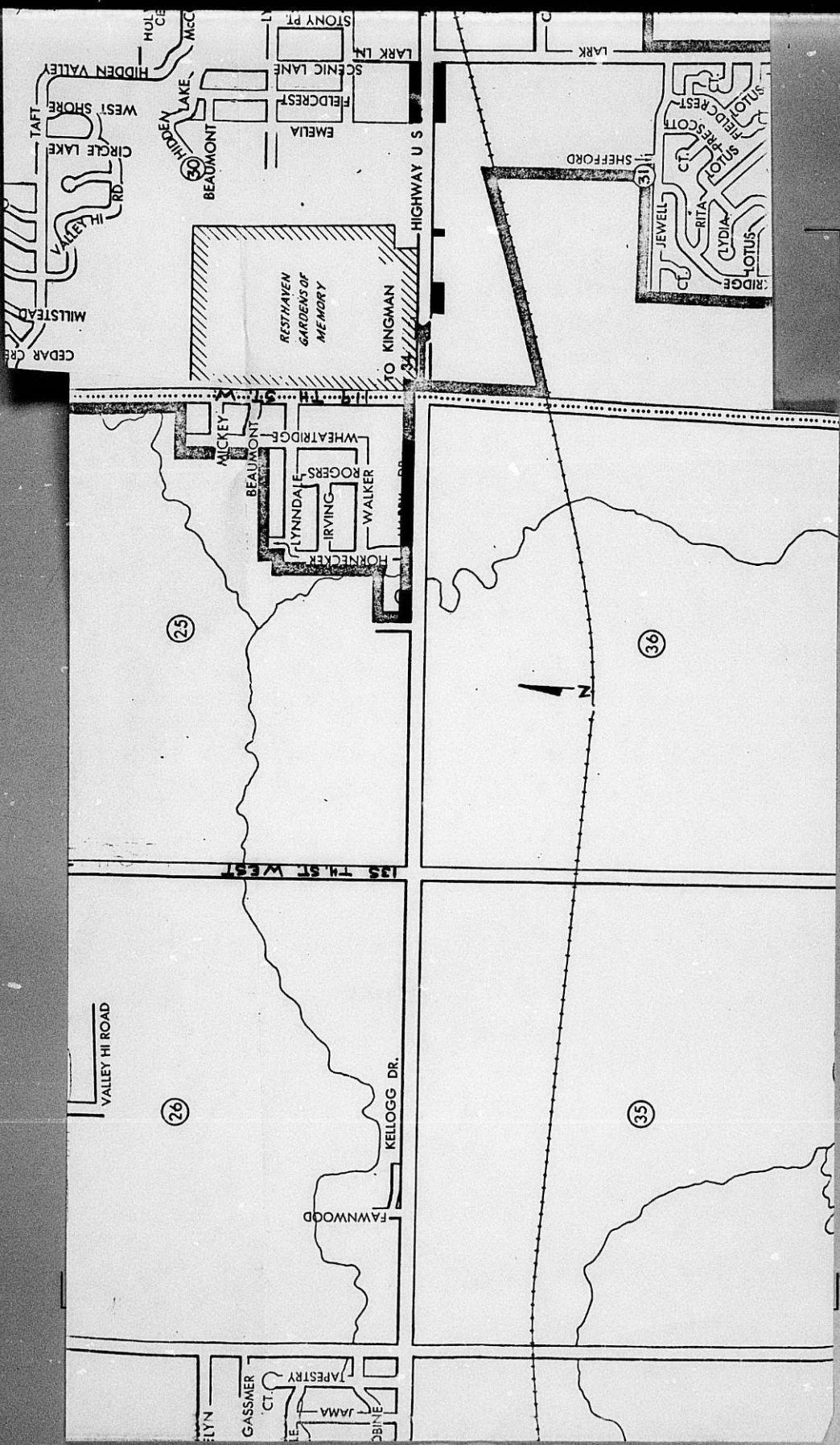

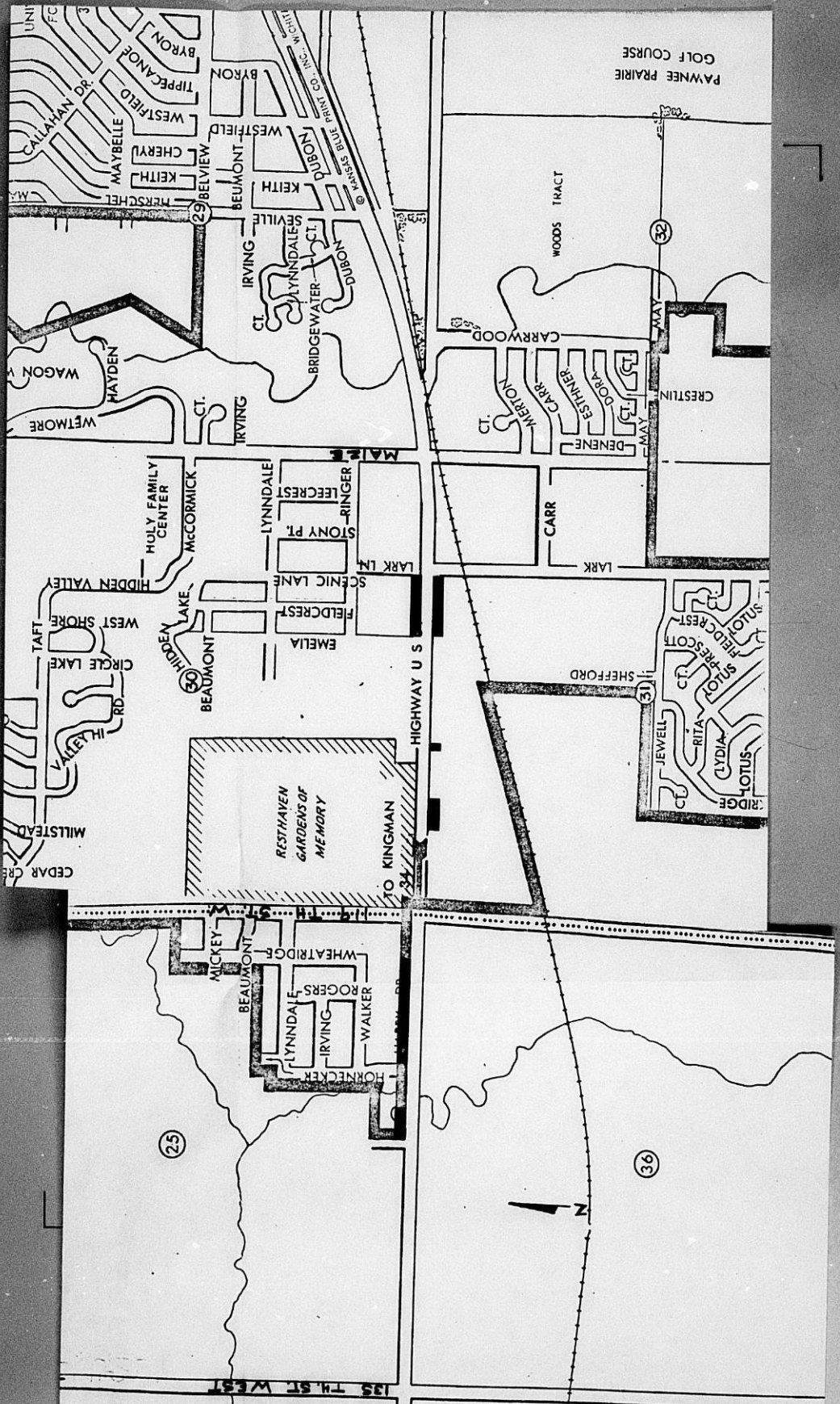
