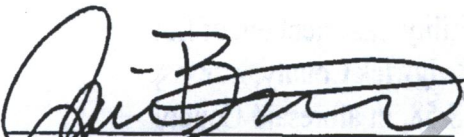

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

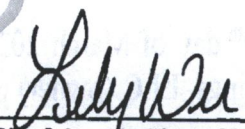
1. That due and legal notice has been given by publication, as required by law, in The Wichita Eagle on February 1, 2024, which was at least 20 days prior to the public hearing.

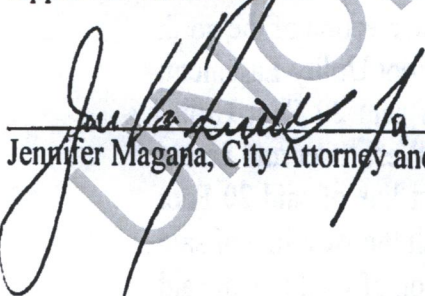

At the **Thursday, February 22, 2024**, meeting of the Metropolitan Area Planning Commission (MAPC), the above-referenced vacation request was approved subject to the following conditions:

- (1) Abandonment or relocation/reconstruction of any/all utilities made necessary by the vacation of the described portion of a utility easement shall be to City Standards and shall be the responsibility and at the expense of the applicant. The applicant shall provide a Private Project Sewer to Public Works and Utilities. As needed provide approval from franchised utilities for the relocation of franchised utilities. All to be provided to the Planning Department prior to this case going to City Council for final action.
- (2) As needed provide Planning with dedication of easements by separate instruments with original signatures to go with the Vacation Order to City Council for final action and subsequent recording with the Vacation Order at the Register of Deeds. All to be provided to the Planning Department prior to this case going to City Council for final action.
- (3) All improvements shall be according to City Standards and at the applicants' expense.
- (4) Per the approval of Public Works, vacate the described portion of platted 16-foot utility easement located on Lot 1, Block 1, Bridgeport Industrial Park 1<sup>st</sup> Addition, Wichita, Sedgwick County, Kansas.
- (5) Provide Planning with a legal description of the vacated portion of the platted utility easement on a Word document via E-mail that can be used on the Vacation Order. This must be provided to the Planning Department prior to this case going to City Council for final action.
- (6) Per MAPC Policy Statement #7, all conditions are to be completed within one year of approval by the MAPC or the vacation request will be considered null and void. All vacation requests are not complete until the Wichita City Council or the

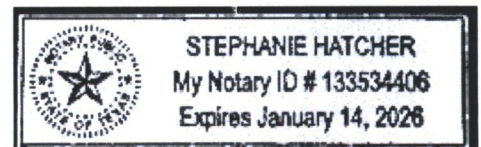

**STAFF REPORT**

**CASE NUMBER:** VAC2024-00003 - Request to vacate a portion of a platted utility easement.

**OWNER/APPLICANT:** Prestige Worldwide Holdings, LLC (applicant)/ Baughman Company, P.A. (Agent)

**LEGAL DESCRIPTION:** Generally described as vacating a portions of platted 10-foot and 20-foot utility easements on Lot 1, Block 1, Bridgeport Industrial Park 1<sup>st</sup> Addition, Wichita, Sedgwick County, Kansas (See attached legal description).

**LOCATION:** Generally located on the east side of North St. Francis Street, within one-quarter mile south of East 37<sup>th</sup> Street North.

**REASON FOR REQUEST:** To permit construction of a warehouse on the subject site.

**CURRENT ZONING:** The subject site and properties on all sides are zoned GI General Industrial District and are either undeveloped or developed with commercial or industrial uses.

**VICINITY MAP:**



The applicant proposes to vacate a portion of an "L"-shaped utility easement on Lot 1, Block 1, Bridgeport Industrial Park 1<sup>st</sup> Addition, see legal description and exhibits. If approved the applicants are intending to build a warehouse on the subject site. The east/west portion of the utility easement is 10 feet wide and the north/south portion of the utility easement is 20 feet wide. There is a dead-end sanitary sewer line in the north/south, 20-foot-wide portion of the subject easement. There are no public utilities in the east/west, 10-foot-wide portion of the utility easement.

Public Works and Utilities does not object to the vacation request. They require a Private Project Sewer to be submitted in order to abandon/privatize the portion of the sewer that is in the existing easement. This will have to be submitted prior to the vacation being scheduled for City Council. Cox does not object to this vacation as they do not have any lines or equipment in the utility easement. Evergy has equipment in the east/west portion of the easement. The applicant is working with Evergy on relocation of the equipment. Relocation is at the applicant's expense. Kevin Rieschick, Subdivision Representative, can be contacted at 785-410-2986 regarding this project. The Bridgeport Industrial Park 1<sup>st</sup> Addition was recorded on March 20, 1985.

Based upon information available prior to the public hearing and reserving the right to make recommendations based on subsequent comments from City Traffic, Public Works/Water & Sewer/Stormwater, Fire, franchised utility representatives and other interested parties, Planning Staff has listed the following considerations (but not limited to) associated with the request to vacate the described portion of the platted utility easement.

- A. That after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, the MAPC makes the following findings:
  1. That due and legal notice has been given by publication as required by law, in the Wichita Eagle, of notice of this vacation proceeding one time February 1, 2024, which was at least 20 days prior to this public hearing.
  2. That no private rights will be injured or endangered by vacating the described portion of the platted utility easement that the public will suffer no loss or inconvenience thereby.
  3. In justice to the petitioner, the prayer of the petition ought to be granted.

Conditions (but not limited to) associated with the request:

- (1) Abandonment or relocation/reconstruction of any/all utilities made necessary by the vacation of the described portion of a utility easement shall be to City Standards and shall be the responsibility and at the expense of the applicant. The applicant shall provide a Private Project Sewer to Public Works and Utilities. As needed provide approval from franchised utilities for the relocation of franchised utilities. All to be provided to the Planning Department prior to this case going to City Council for final action.
- (2) As needed provide Planning with dedication of easements by separate instruments with original signatures to go with the Vacation Order to City Council for final action and subsequent recording with the Vacation Order at the Register of Deeds. All to be provided to the Planning Department prior to this case going to City Council for final action.
- (3) All improvements shall be according to City Standards and at the applicants' expense.

- (4) Per the approval of Public Works, vacate the described portion of platted 16-foot utility easement located on Lot 1, Block 1, Bridgeport Industrial Park 1<sup>st</sup> Addition, Wichita, Sedgwick County, Kansas.
- (5) Provide Planning with a legal description of the vacated portion of the platted utility easement on a Word document via E-mail that can be used on the Vacation Order. This must be provided to the Planning Department prior to this case going to City Council for final action.
- (6) Per MAPC Policy Statement #7, all conditions are to be completed within one year of approval by the MAPC or the vacation request will be considered null and void. All vacation requests are not complete until the Wichita City Council or the Sedgwick County Board of County Commissioners have taken final action on the request and the vacation order and all required documents have been provided to the City, County and/or franchised utilities and the necessary documents have been recorded with the Register of Deeds.

#### **SUBDIVISION COMMITTEE'S RECOMMENDED ACTION**

The Subdivision Committee recommends approval per staff recommendations.

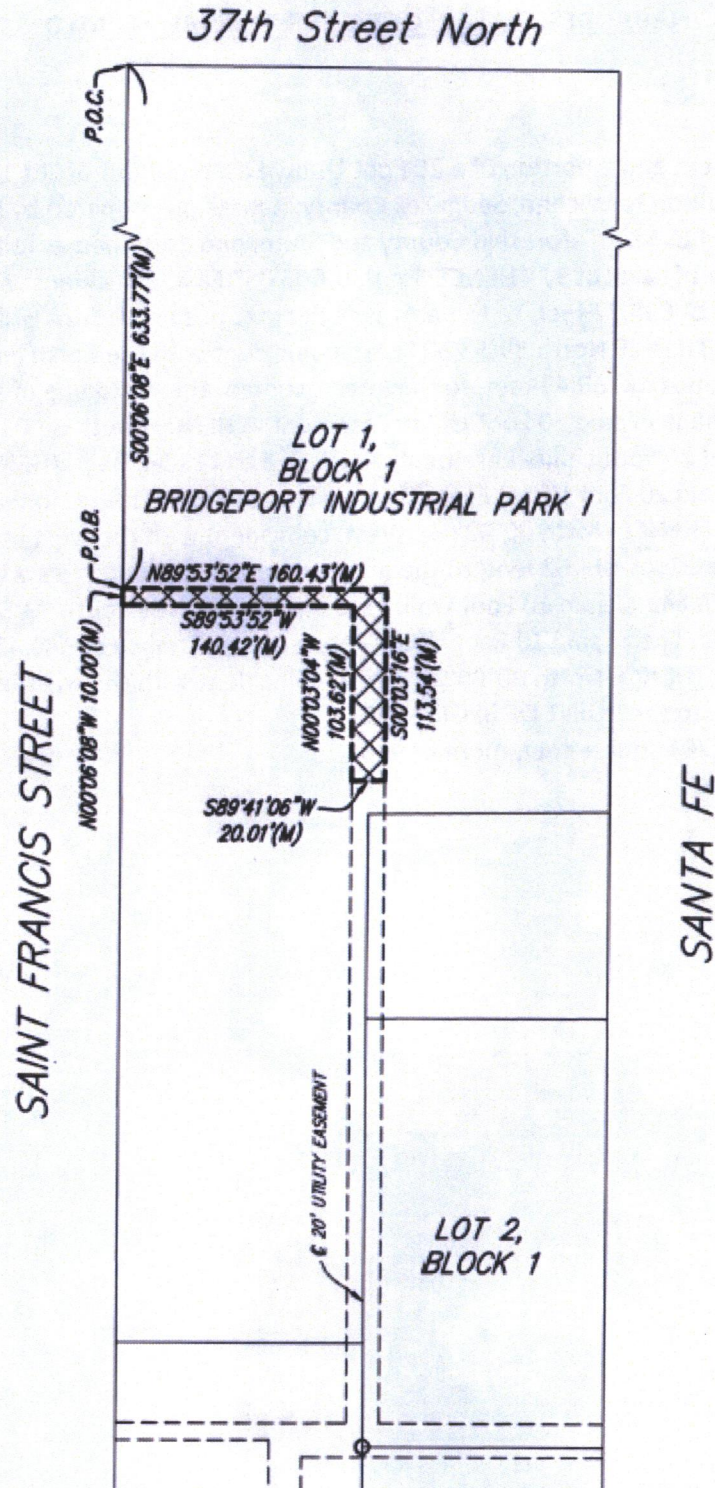

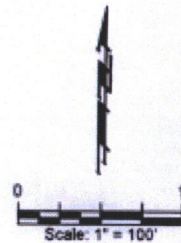
