REQUEST FOR ZONING

SCZ-0568 - ZONE CHANGE FROM THE "LC" LIGHT COMMERCIAL DISTRICT
TO THE "AA" ONE-FAMILY DWELLING DISTRICT, LOCATED AT THE
NORTHEAST CORNER OF HOOVER AND MACARTHUR.

The MAPC recommends that the application be approved.

On January 21, 1987, the Board of County Commissioners approved the above-referenced zone change subject to platting the property within one year or the case be considered denied and closed.
