

RECOMMENDATION FROM METROPOLITAN AREA PLANNING COMMISSION
TO BOARD OF COUNTY COMMISSIONERS

SCZ-0595 & CU-318 - ZONE CHANGE FROM THE "R" RURAL RESIDENTIAL DISTRICT TO THE "R-1" SUBURBAN RESIDENTIAL DISTRICT AND ASSOCIATED CONDITIONAL USE PERMIT FOR A RELIGIOUS/EDUCATIONAL FACILITY, LOCATED ON THE WEST SIDE OF WEBB ROAD IN AN AREA NORTH OF 55TH STREET SOUTH.

The MAPC recommends that the applications be approved, subject to conditions (see minutes for full motion).

GARDNER moved, MILES seconded, and the motion carried with a vote of 8-1 (GARDNER, MILES, BRINEGAR, BROWN, CROCKETT, FAIRBANKS, GOEBEL and SHERMAN in favor; PARSONS opposed; MOORE was absent).

ACTION:

1. Adopt the findings of fact of the Metropolitan Area Planning Commission and approve the zone change and associated conditional use permit, subject to the recommended conditions; adopt resolutions establishing the zone change and conditional use permit and instruct the Planning Department to withhold publication until the plat has been recorded with the Register of Deeds; or
2. Adopt findings and deny the application.

RESOLUTION NO. 27-1989

A RESOLUTION CHANGING THE ZONING CLASSIFICATIONS FOR CERTAIN LANDS LOCATED WITHIN THE UNINCORPORATED AREA OF SEDGWICK COUNTY, KANSAS, UNDER THE AUTHORITY GRANTED IN SECTION 17.C OF THE ZONING REGULATIONS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, DECEMBER 12, 1984.

BE IT RESOLVED BY THE GOVERNING BODY OF SEDGWICK COUNTY, KANSAS:

SECTION I. That after receiving a recommendation from the Wichita-Sedgwick County Metropolitan Area Planning Commission, and after said Planning Commission has given proper notice and held a public hearing as provided by law, and under authority granted by Section 17.C of the Zoning Regulations, the zoning district of the lands legally described below are hereby changed as follows:

CASE NO. SCZ-0595

Zone change from the "R" Rural Residential District to the "R-1" Suburban Residential District

The west 1,050 feet of the east 1,100 feet of the north 660 feet of the SE 1/4, Section 20, Township 28 South, Range 2 East of the 6th P.M., Sedgwick County, Kansas. Generally located on the west side of Webb Road in an area north of 55th Street South.

SECTION II. That upon the taking effect of this Resolution, the notation of such zone change shall be entered in the official zoning atlas on file in the Office of the County Zoning Administrator and in the Office of the Wichita-Sedgwick County Metropolitan Area Planning Commission.

SECTION III. That this Resolution shall take effect and be in force from and after its adoption and publication in the official county paper.
