REQUEST FOR ZONING

SCZ-0646 - REQUEST FOR ZONE CHANGE FROM "R" RURAL RESIDENTIAL DISTRICT TO THE "C" COMMERCIAL DISTRICT, LOCATED AT THE NORTHEAST CORNER OF 63RD STREET SOUTH AND HYDRAULIC.

The MAPC recommends that the zone change request be approved subject to platting, and it carried by a vote of 9 in favor (Breckenridge, Goebel, Haggard, Nestleroad, McKay, Miles, Polczinski, and Winkler) and 1 opposed (Osborne-Howes). Frye, Lopez and Sherman were absent. One vacancy.

- ACTION:
1. Adopt the findings of fact of the Metropolitan Area Planning Commission and approve the zone change subject to the condition of platting; adopt a resolution establishing the zone change and instruct the Planning Department to withhold publication until the plat has been recorded with the Register of Deeds; or
 2. Adopt findings and deny the application; or
 3. Override Planning Commission's recommendation by a 2/3 majority vote of the membership of the governing body.

RESOLUTION NO. 216-1993

A RESOLUTION CHANGING THE ZONING CLASSIFICATION FOR CERTAIN LANDS LOCATED WITHIN THE UNINCORPORATED AREA OF SEDGWICK COUNTY, KANSAS, UNDER THE AUTHORITY GRANTED IN SECTION 7.C OF THE ZONING REGULATIONS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, DECEMBER 12, 1984 AND SUBSEQUENTLY AMENDED.

BE IT RESOLVED BY THE GOVERNING BODY OF SEDGWICK COUNTY, KANSAS.

SECTION I. That after receiving a recommendation from the Wichita-Sedgwick County Metropolitan Area Planning Commission, and after said Planning Commission has given proper notice and held a public hearing as provided by law, and under authority granted by Section 17.C of the Zoning Regulations, the zoning district of the lands legally described below are hereby changed as follows:

Case No. SCZ-0646

Zone change request from "R" Rural Residential District to the "C" Commercial District

Lots 1 and 3, Block A, Fran's Addition, Sedgwick County, Kansas. Generally located at the northeast corner of 63rd Street South and Hydraulic.

SECTION II. That upon the taking effect of this Resolution, the notation of such zone change shall be entered in the official zoning atlas on file in the Office of the County Zoning Administrator and in the Office of the Wichita-Sedgwick County Metropolitan Area Planning Department.

SECTION III. That this Resolution shall take effect and be in force from and after its adoption and publication in the official county paper.

SECTION IV. This Resolution is made in order to correct the legal description which appears in Section I of County Resolution No. 113-1993, passed May 19, 1993.
