

RECOMMENDATION FROM METROPOLITAN AREA PLANNING COMMISSION  
TO BOARD OF COUNTY COMMISSIONERS

REQUEST FOR ZONING

SCZ-0626 - REQUEST FOR ZONE CHANGE FROM "R" RURAL RESIDENTIAL DISTRICT TO "R-1" SUBURBAN RESIDENTIAL DISTRICT, LOCATED ON THE EAST SIDE OF HILLSIDE, APPROXIMATELY 1/4 MILE SOUTH OF 79TH STREET SOUTH (8044 S. HILLSIDE).

The MAPC recommends that the application be approved. (see minutes for full motion).

Goebel moved, Parsons seconded, and it carried with a vote of 6 in favor (Goebel, Parsons, Breckenridge, McIntyre, Miles and Sherman) and 1 opposed (Winkler). Gardner, Gramke and Hunt were absent.

- ACTION:
1. Adopt the findings of fact of the Metropolitan Area Planning Commission and approve the zone change subject to the condition of platting; adopt a resolution establishing the zone change and instruct the Planning Department to withhold publication until the plat has been recorded with the Register of Deeds; or
  2. Adopt findings and deny the application.

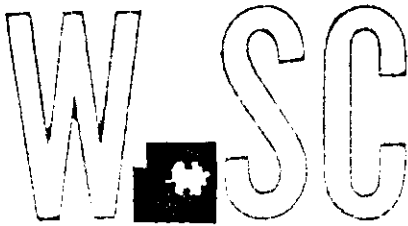



Dear Mr. Knabe:

On May 8, 1991, the Board of County Commissioners considered the above-captioned case. The action taken by the Commission was not to approve the request. A motion for approval received only a 3-2 vote in favor, whereas a unanimous vote was required. A unanimous vote was necessary, since the City of Derby chose to recommend against the proposed zone change and more than 20% of the property owners within 1,000 feet of the application area filed protest petitions against the zone change. The case file has been so marked and closed.
