RECOMMENDATION FROM MAPC TO BOARD OF CITY COMMISSIONERS

V-1237 - VACATION OF CLARENCE AVENUE AS PLATTED IN SILVER SPUR
SECOND ADDITION LOCATED 1/4 TO 1/2 MILE SOUTH OF MacARTHUR MIDWAY
BETWEEN SENECA AND MERIDIAN.

The Planning Commission recommends approval subject to:

- A. The vacated street right-of-way shall be retained as a drainage and utility easement in the vacation ordinance.
- B. Approval of this vacation case shall be subject to completion of the South Lake 3rd Addition plat.
- C. All proceedings shall be without cost to the City, County, or any utility company.

or inconvenience thereby.

to be granted.

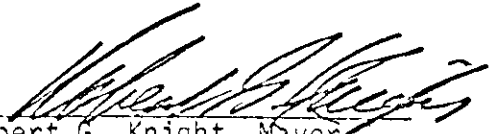
4. No written objection to said vacation has been filed with the

as a utility and drainage easement in accordance with K.S.A. 12-512(a).

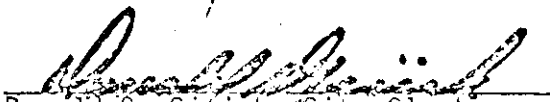
6. The vacation of the street right-of-way described herein should be

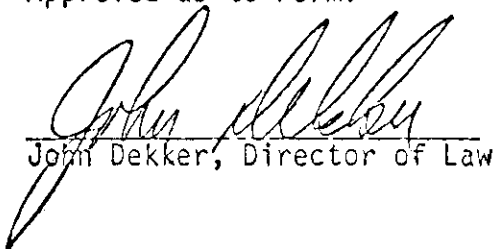

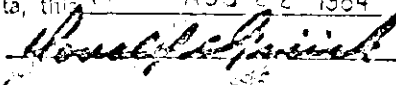
