

RECOMMENDATION FROM MAPC TO BOARD OF CITY COMMISSIONERS

V-1215 - VACTION OF A PORTION OF THE PLATTED ACCESS CONTROL TO PAWNEE ACROSS THE
NORTH LINE OF LOT 1, BLOCK 1, WICHITA BUILDERS 3RD ADDITION.

The Planning Commission recommends approval subject to:

- A. The vacation ordinance shall retain the platted access control except for one point of access across the east 65 feet of the west 110 feet of the north line of Lot 1.
- B. All proceedings shall be without cost to the City, County, or any utility company.

ORDINANCE NO. 38-S32

AN ORDINANCE VACATING A PORTION OF THE PLATTED ACCESS CONTROL TO PAWNEE ACROSS THE NORTH LINE OF LOT 1, BLOCK 1, WICHITA BUILDERS 3RD ADDITION, WICHITA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the platted access control described as follows, to-wit:

The platted "complete access control" to Pawnee across the east 65 feet of the west 110 feet of the north line of Lot 1, Block 1, Wichita Builders 3rd Addition, Wichita, Kansas; (MACP NO. V-1215);

be and the same is hereby vacated in accordance with K.S.A. 13-443.

SECTION 2. That there is hereby retained access control except for one opening across the east 65 feet of the west 110 feet of the north line of said Lot 1 in accordance with K.S.A. 12-512(a).

SECTION 3. That this Ordinance shall be in force and take effect from and after its passage and publication once in the official city paper.
