Staff Recommendation: Approve vacation of easements.

MAPC Recommendation: Approve vacation of easements. (unanimous)

Background: This vacation case has been requested in order to provide additional buildable area for construction of additional facilities for Wichita State University's Physical Plan Complex. The Utility Advisory Committee has verified that the easements are not needed for either existing or planned utilities. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

VACATION ORDER

NOW on this 10th day of November, 1987, comes on for hearing the petition for vacation filed by the Wichita Public Building Commission, praying for the vacation of the following described portions of platted easements and easements granted by separate instruments, to-wit:

The platted utility easement legally described as: The west 10.00 feet of the north 301.50 feet of Lot 1, Wheatshocker Addition to Wichita, Sedgwick County, Kansas.

The platted utility easement legally described as: The north 115.00 feet of the east 20.00 feet of the west 320.00 feet of Lot 1, Wheatshocker Addition to Wichita, Sedgwick County, Kansas.

The portion of a water easement granted on Misc. Bk. 557, page 544, legally described as the north 115 feet of the following described tract: Beginning at a point 320 feet east and 40 feet north of the southwest corner of the NE $\frac{1}{4}$, section 11, township 27 south, range 1 east, said point being on the north line of 17th Street; thence north along a line parallel with the west line of the Wheatshocker Addition, a distance of 611.5 feet to the south line of 18th Street; thence east along said south line of 18th Street, a distance of 10 feet; thence south along a line parallel with the west line of the Wheatshocker Addition, a distance of 611.5 feet to the north line of 17th Street; thence west along said north line of 17th Street, a distance of 10 feet to the point of beginning.

The portion of a sewer easement granted on Misc. Bk. 559, page 105, legally described as follows: That part of Lot 1, Wheatshocker Addition, described as follows: Beginning at a point on the north line of Lot 1 and two hundred eighty-five (285) feet east of the northwest corner of said Lot 1; thence east fifteen (15) feet; thence south parallel to the west line of said Lot 1, a distance of one hundred ten (110) feet, thence northwesterly to a point fifty (50) feet south and two hundred sixty (260) feet east of the northwest corner of said Lot 1; thence northeasterly to the point of beginning. The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on OCT. 21 & 23, 1987.

2. No private rights will be injured or endangered by the vacation of the above-described easements, and the public will suffer no loss or inconvenience thereby.

3. In justice to the petitioner(s) the prayer of the petition ought to be granted.

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.

6.00 5. The vacation of the easements described herein should be approved.

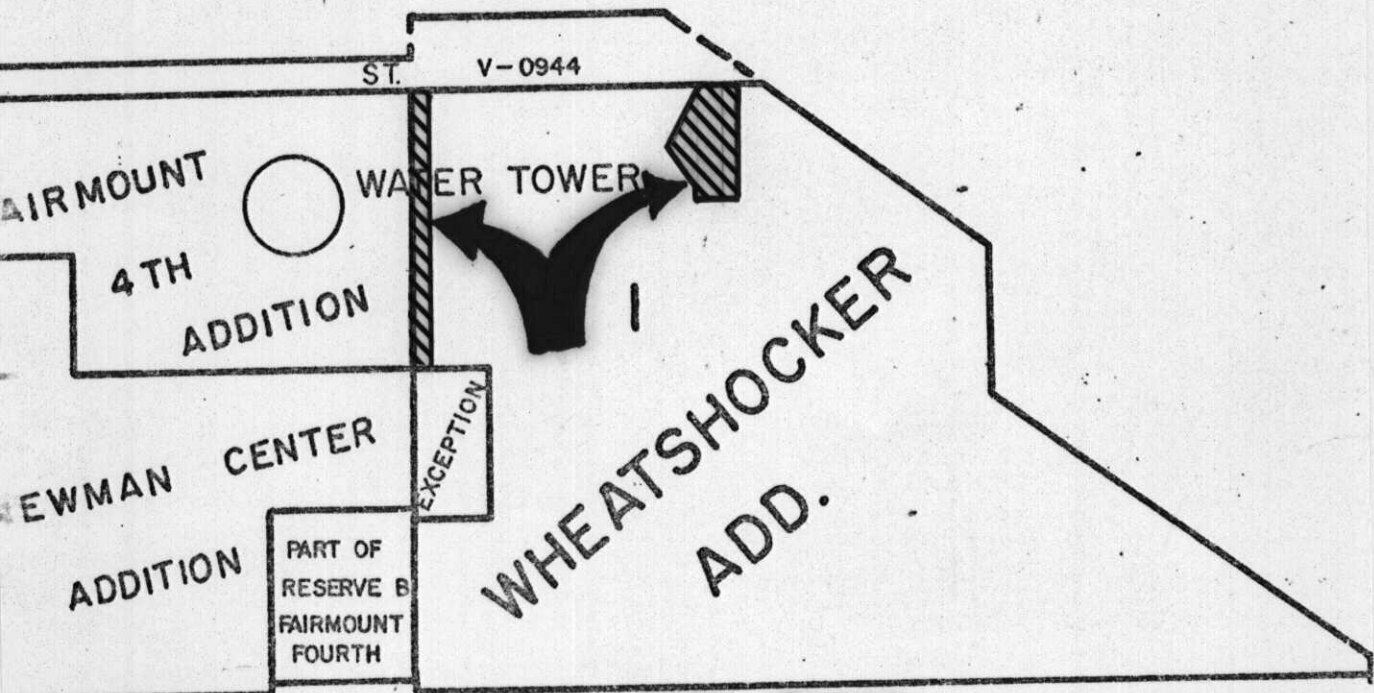
