SUBJECT: V-1477 - REQUEST TO VACATE STREET RIGHT-OF-WAY.

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of street right-of-way.

MAPC Recommendation: Approve vacation of street right-of-way. (unanimous)

Location: In an area north of Pawnee and east of Grove. (District #3).

Applicant: John G. Wurth, 120 S. Market, Suite 400, Wichita, KS 67202

Site Size: An irregularly-shaped area containing approximately 2,587 square feet.

Current Zoning: "R-6" (General Residence)

Background: When the plat of Chilton's Pawnee and Grove Addition was subdivided in 1975, a petition was approved by the City Commission which provided for the pavement of the cul-de-sac right-of-way that this vacation case requests for vacation. In 1984, the City Commission voted unanimously to abandoned this petition at the request of neighborhood residents to the north of the Chilton's Pawnee and Grove Addition. Those persons voiced opposition to the paving project because they believed that, if the cul-de-sac was constructed, apartment residents would park on the cul-de-sac and thereby congest the street.

After hearing the history associated with the paving petition, the Subdivision Committee voted to recommend approval of the vacation request subject to the applicant granting "complete access control" to Poplar Street from the vacated right-of-way. The full Planning Commission unanimously agreed with this recommendation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Close public hearing; approve vacation; accept access control dedication; authorize the Mayor to sign the Vacation Order; and record certified copy of Order and instrument dedicating access control, recording costs to be billed to:
