Staff Recommendation: Approve vacation of a floodway reserve.

Background: Based upon current information, the County has determined that the are of this floodway reserve may be vacated. A new floodway reserve agreement has been prepared and will be in effect upon approval of this vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: This request for vacation is located on property outside the City of Wichita, but within three miles thereof. As such, no petition, publication of notification or public hearing is required before the Wichita City Council.
