Staff Recommendation: Approve vacation of utility easements.

Background: This vacation case has been requested in order to provide an area for construction of a masonry wall along Harry Street. The utility easement was required by the County Engineer's Office in order to maintain adequate easement for a sanitary sewer line. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: This request for vacation is located on property outside the City of Wichita, but within three miles thereof. As such, no petition, publication of notification or public hearing is required before the Wichita City Council.
