Staff Recommendation: Approve vacation of minimum building pad
elevation.

Background: This vacation is requested as the existing structure on
the lot is built below the platted minimum building pad elevation and
thus is needed to clear title. City Engineering has proposed a
revised minimum building pad elevation which is established on the
Vacation Order. The vacation request has been reviewed and approved
by the Planning Commission, subject to conditions.

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on 8/30 & 9/6/89.
2. No private rights will be injured or endangered by the vacation of the above-described minimum building pad elevation, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The minimum building pad elevation is hereby 168.0 City Datum feet and 1355.4 M.S.L. feet for the above described property.
6. The vacation of the minimum building pad elevation described herein should be approved.

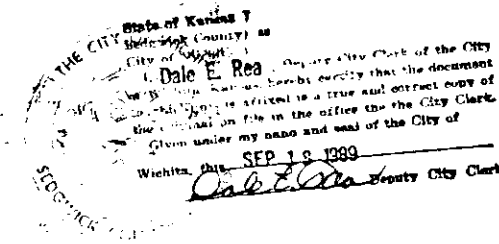
