Staff Recommendation: Approve vacation of utility easement.

MAPC Recommendation: Approve vacation of utility easement.
(unanimous)

Background: The applicant desires more buildable area for construction of single-family homes on the involved lots. The Utility Advisory Committee has indicated that the sections of easements involved in the vacation are not needed and that no adverse effects will result by this vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

The 10 foot platted utility easement adjacent to the east lot line of Lot 29, Block 3, Brush Creek Addition, Wichita, Kansas.

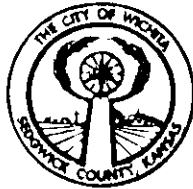
The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on JUN 28 1989 + JUL 5 1989.
2. No private rights will be injured or endangered by the vacation of the above-described platted utility easement, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. This vacation order shall except out the south 20 feet of both areas to be vacated.
6. The vacation of the platted utility easement described herein should be approved.

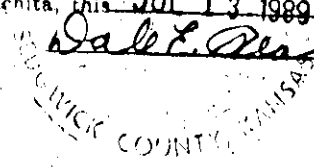
