Staff Recommendation: Approve vacation of building setback.

Background: The configuration of this lot and its location adjacent to a cul-de-sac has limited the buildable area of the lot. The applicant is requesting the reduction of the front yard building setback by 5-feet. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

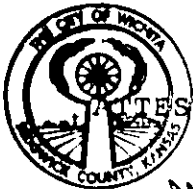

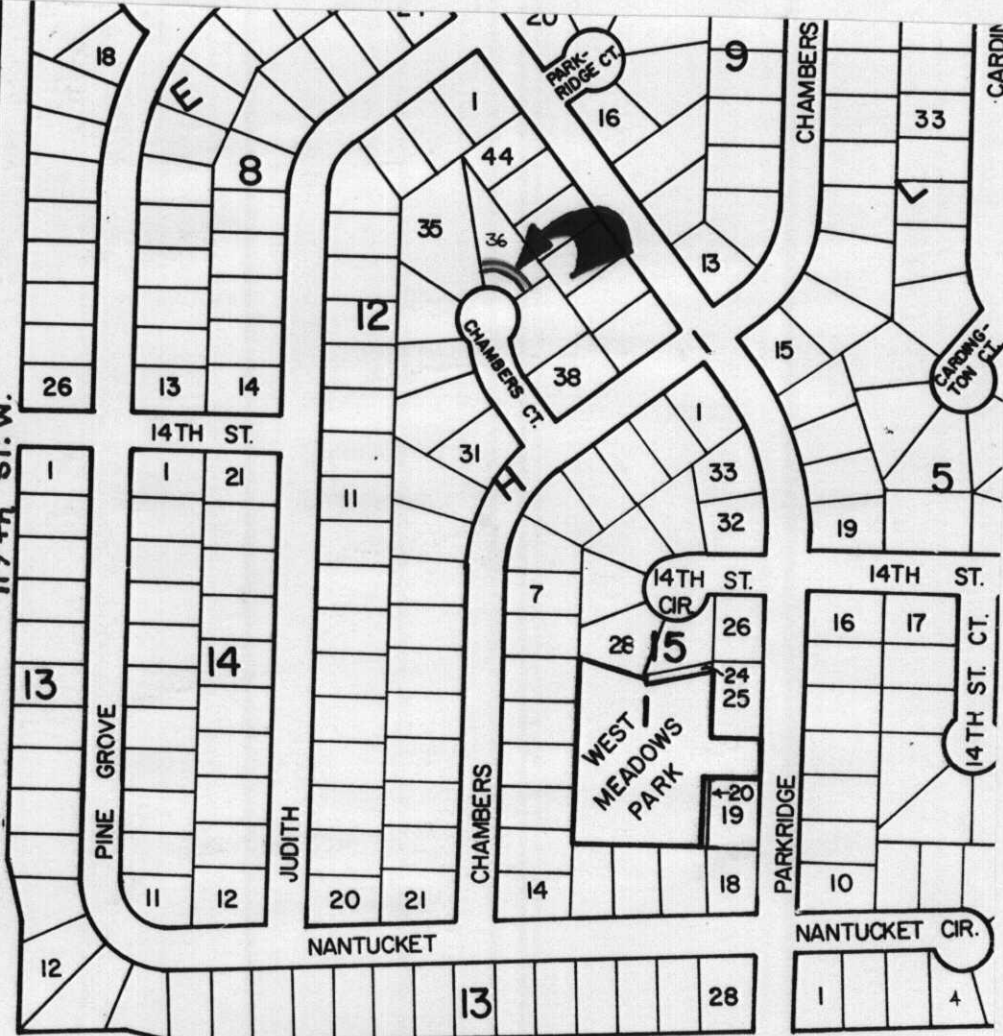
