Staff Recommendation: Approve vacation of street right-of-way.

MAPC Recommendation: Approve vacation of street right-of-way.
(unanimous)

Background: A plat for City property along the south line of Osie has proposed the vacation of Osie as part of the plat. Consequently, property owners to the north of Osie were requested to participate in the vacation of the corresponding sections of Osie adjacent to their property. These property owners have agreed to this vacation and have submitted the application reflected by this vacation case. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

VACATION ORDER

NOW on this 5th day of June, 1990, comes on for hearing the petition for vacation filed by Archie Dean Conduff, et al., praying for the vacation of the following described street right-of-way, to-wit:

The N 1/2 of Osie Street lying south of and adjacent to Lot 12, Block 2, Grillot Addition to Wichita, Kansas, and that part of the N 1/2 of Osie Street, lying south of and adjacent to Lot 11, Block 2, Grillot Addition to Wichita, Kansas, described as beginning at the SE corner of said Lot 11, thence S90°W, along the south line of said Lot 11, 130 feet to the SW corner of said Lot 11; thence S00°21'W, along the west line of said Lot 11, extended south, 40 feet to the center-line of said Osie Street; thence N 90° E, along the center-line of said Osie Street, 63.91 feet to a point on the curve, having a radius of 75 feet, said radius point being S00°W, 75 feet from the SE corner of said Lot 11; thence northeasterly, along said curve, being a curve to the right, an arc distance of 81.40 feet to the place of beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

- 1. That due and legal notice has been given by publication as required by law, by publication in the Daily Record of notice of this vacation proceeding for consecutive weeks on MAY 22 1990 MAY 29 1990
2. No private rights will be injured or endangered by the vacation of the above-described street right-of-way, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.


4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
