Background: This vacation involves the site for a planned Fire station. The original platted lot was only allowed two access openings, the Firestation itself will require two openings and the vacation of access control is being requested to allow the remaining portion of the original lot to continue having two openings as previously allowed. The vacation of the building setback will only involved the poriton of the lot to be used for the Firestation. The Subdivision Committee has indicated support for the vacaition and that no advese effects should result. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.
