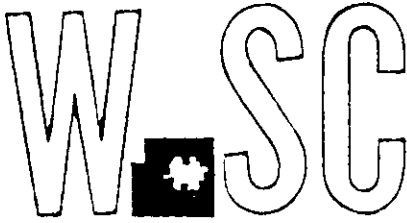

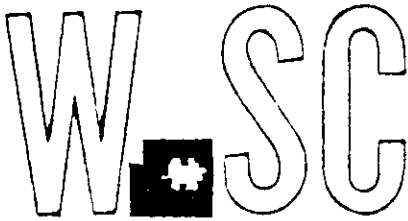

This matter will be forwarded to the Planning Commission for its consideration on Thursday, December 5, 1991 at 1:30 p.m.

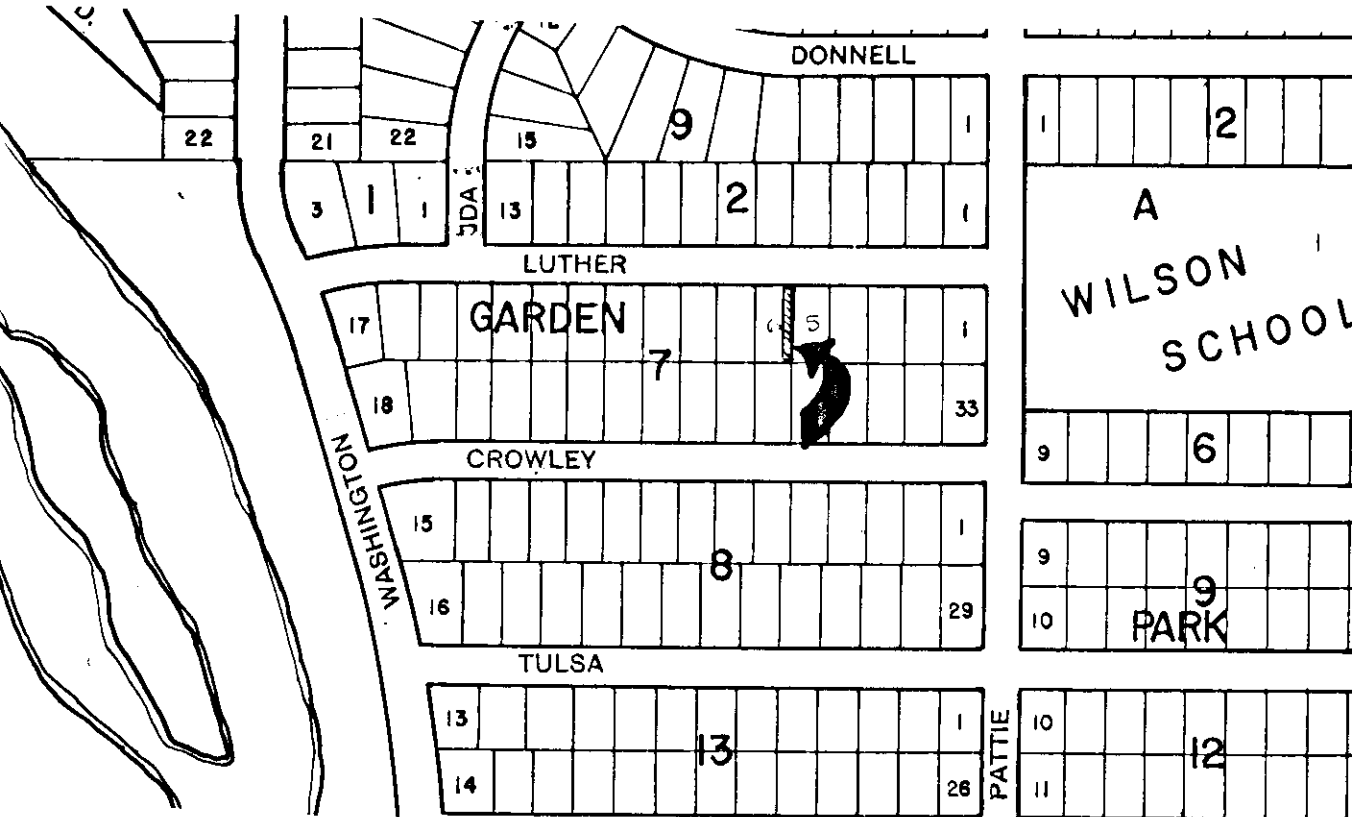

LEGAL DESCRIPTION: The five (5) foot easement as platted adjacent to the east line of lot 6, Block 7, Garden Park Addition to Wichita Sedgwick County, Kansas, except the south 8 feet thereof.

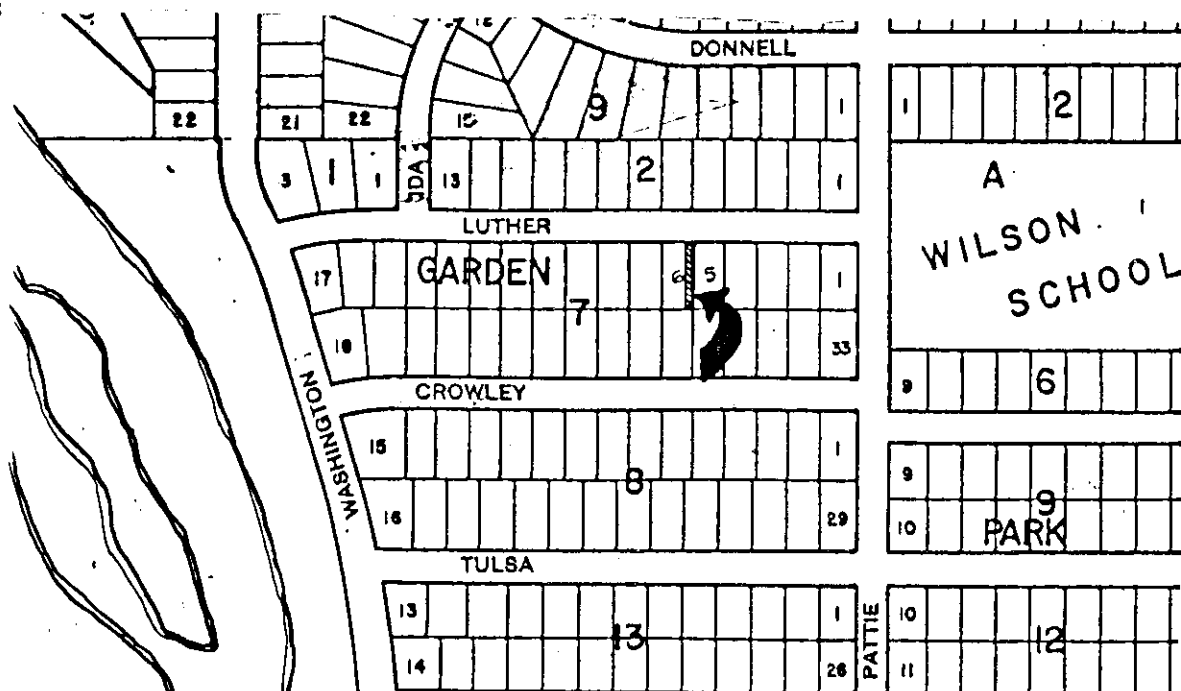
LOCATION: North of 31st St. S. and west of Hydraulic
