Background: Additional area for parking, landscaping and lighting is needed along the south line of a platted drainage easement. The applicant has submitted a substitute easement to the north to compensate for the area vacated. City Engineering has indicated that the substitute easement is sufficient to off-set the area requested for vacation. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Action: Accept the substitute drainage dedication, close the public hearing, approve vacation; authorize the Mayor to sign the Vacation Order; and record the Certified copy of the order and drainage easements, recording costs to be billed to:

Commencing at the southwest corner of said Lot 1; thence N45°00'00"E, 254.32 feet along the platted drainage easement, to the point of beginning; thence N45°00'00"E, 14.14 feet; thence N90°00'00"E, 365.17 feet to the east line of said drainage easement; thence S00°00'00"E, 10.00 feet to the southeast corner of said drainage easement; thence S90°00'00"W, 375.17 feet along said south line to the point of beginning.

5. The vacation of the drainage easement described herein should be approved.


