**Staff Recommendation:** Approve vacation of access control.

**MAPC Recommendation:** Approve vacation of access control. (unanimous)

**Background:** The vacation is basically being requested to relocate an opening. The applicant is dedicating complete access control on a lot to the east, while the vacation allows for one (1) additional opening on the property involved in the vacation. In addition, the applicant has submitted a petition to extend a deceleration lane in order to better serve the planned opening. This petition also provides for the closure of an opening located in the area now being dedicated for complete access control. A Certificate of Petitions has been provided in regard to these improvements. Both City and Traffic Engineering have indicated that the vacation is acceptable. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

**Legal Considerations:** The City Clerk needs to certify as to proper notification and no filing of written protest.

**Recommendations/Actions:** Accept the dedication of access control; close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; record the certified copy of the Vacation Order, the Certificate of Petitions and dedication of access control; recording costs to be billed to:


