SUBJECT: V- 1828; Request to vacate utility and drainage easements, generally located south of 37th Street North and east of Oliver. (District # 4).

INITIATED BY: Metropolitan Area Planning Department

AGENDA ACTION: Planning



Staff Recommendation: Approve vacation.

MAPC Recommendation: Approve vacation (unanimous).

Background: This is the vacation of portions of platted utility and drainage easements. Applicant, Koch Industries, intends to convey to Goodwill Industries, which is adjacent and to the south of the Koch property, additional vehicular access around the expanded Goodwill facilities. A lot split has also been filed for these properties, so that the Koch and Goodwill properties will continue to be considered legally buildable sites. A substitute easement has been provided to relocate the existing drainage and utility easements. Staff and MAPC have recommended approval because drainage and utility needs will be satisfied by the substitute easement, and the vacation will not adversely affect the public interest.

This vacation has been reviewed and approved by the Planning Commission, subject to conditions and recording within 30 days.

RECOMMENDATIONS/ACTIONS: Close the public hearing; accept the drainage and utility easement; approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Order and the drainage and utility easement, recording costs to be billed to:

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on _____.
