SUBJECT: PUBLIC HEARING V-1901 REQUEST TO VACATE A BUILDING
SETBACK

INITIATED BY: Metropolitan Area Planning Department



AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of building setback.

MAPC Recommendation: Approve vacation of building setback.. (unanimous)

Background: This corner lot was platted with 30-foot building setbacks to both adjacent streets. The street to the east, Eilison is only a half street and has not yet been installed. The applicant is requesting to vacate a portion of the setback to Eilison in order to provide additional area for a planned expansion to the existing residence. No utilities will be impacted and both County Engineering and the utility representatives of the Subdivision Committee had no objections to the vacations, also no abutting property owners have indicated any objections at this point. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: This request for vacation is located on property outside the City of Wichita, but within three miles thereof. As such, no petition, publication of notification or public hearing is required before the Wichita City Council.

WHEREUPON, it is shown that proper notice has been given by
 publication once each week for three consecutive weeks in the official
 county newspaper, the first such publication having occurred on April
 7, 1995, and it is further shown that proper proof of such publication
 has been filed herein. The Board finds that such notice is in lawful
 form and that it conforms to K.S.A. 58-2613.

THEREAFTER, the Board, having heard all interested parties and
 being otherwise duly advised in the premises, finds and determines
 that no private rights will be injured or endangered by such vacation;
 that the public will suffer no loss or inconvenience thereby; that
 no written objections hereto have been filed with the Sedgwick County
 Clerk; and that, in justice to the petitioner, the petition's prayer
 should be granted.
