Staff Recommendation: Approve vacation of drainage easement.

MAPC Recommendation: Approve vacation of drainage easement.
(unanimous)

Background: A planned expansion to an existing building requires the relocation of a drainage improvement and vacation of the associated easement. The applicant has submitted a substitute easement and will be responsible for installing the needed drainage improvements in the new easement. City Engineering has agreed that the change in easement locations is acceptable. As requested by City Engineering the applicant is submitting a temporary easement that corresponds to the area requested for vacation. This temporary easement will remain in place until the substitute improvement is completed. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions:

Accept the substitute and temporary easements; close the public hearing; approve the vacation; authorize the Mayor to sign the Vacation Order; and record the Certified Copy of the Vacation Order and the utility easements; recording costs to be billed to:

Beginning at a point 55 feet east and 5 feet north of the Southwest Corner of Lot 1; thence east parallel with the south line of Lot 1 to a point 270 feet south and 70 feet west of the northeast corner of Lot 2, thence south parallel with the east line of Lot 2, a distance of 20 feet; thence west parallel with the south line of Lot 1 to a point 55 feet east and 15 feet south of the southwest corner of Lot 1, thence north 20 feet to the point of beginning; Chelsea North Addition to Wichita, Kansas. (V-1900)

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

2. No private rights will be injured or endangered by the vacation of the above-described drainage easement, and the public will suffer no loss or inconvenience thereby.

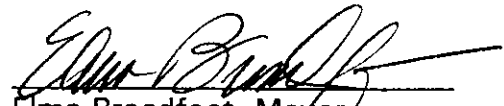

5. The vacation of the drainage easement described herein should be approved.

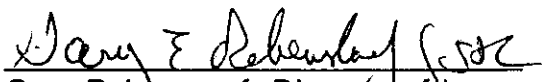
