SUBJECT: PUBLIC HEARING V-1887 Request to vacate access control to Airport Road in an area south of Kellogg and east of Ridge Road.
(District #5)

INITIATED BY: Metropolitan Area Planning Department



AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of access control.

MAPC Recommendation: Approve vacation of access control. (unanimous)

Background: When the involved properties were platted Airport Road was the major means of access to and from Mid Continent Airport and access control was acquired to limit or control traffic to that street. A planned development at this site intends to use access out to Airport Road. Access is actually, though, also controlled by the Airport Authority who controls a reserve across which any road or drive would cross from this site to Airport Road. Consequently, City and Traffic Engineering and the Subdivision Committee agree that the platted access control is unnecessary and can be vacated. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions:

Close the public hearing, approve the vacation;
authorize the Mayor to sign the Vacation Order; and

3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the access control described herein should be approved.

IT IS, THEREFORE, BY THE CITY COUNCIL, on this 15th day of November, 1994, ordered that the above-described access control is hereby vacated. IT IS FURTHER ORDERED that the City Clerk shall certify a copy of this order to the Register of Deeds of Sedgwick County.
