SUBJECT: PUBLIC HEARING V-1929 REQUEST TO VACATE UTILITY EASEMENT
IN AN AREA WEST OF WEBB AND NORTH OF CENTRAL.
(District #2)

INITIATED BY: Metropolitan Area Planning Department *M.K.*

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of utility easement.

MAPC Recommendation: Approve vacation of utility easement. (unanimous)

Background: The applicant desires to vacate the east 4 feet of a 10 foot utility easement to allow a swimming pool to remain at its existing location on the lot. A substitute easement has been submitted for a 5 foot strip abutting this easement to the west, in which City Engineering and representatives of the utilities on the Subdivision Committee indicate the utilities have actually been installed. The swimming pool also encroaches into a large private pipeline easement, which is still the owner's responsibility to resolve privately. The vacation request has been reviewed and approved by the Planning Commission, subject to conditions.

Legal Considerations: The City Clerk needs to certify as to proper notification and no filing of written protest.

Recommendations/Actions:

Accept the utility easement; close the public hearing, approve the vacation; authorize the Mayor to sign the Vacation Order; and record the certified copy of the Vacation Order; and utility easement recording costs to be billed to: 150029-2909

That portion of a utility easement described as:

From the southeast corner of Lot 23, Block 1, Gatewood Second Addition, Wichita, Sedgwick County, Kansas; thence northwesterly on the southerly line of said Lot 23 to the east line of a platted ten foot wide utility easement; thence north on the east line of said easement a distance of 45 feet to the point of beginning; thence continuing north on the east line of said easement a distance of 70 feet; thence west four feet; thence south parallel to the east line of said easement a distance of 70 feet; thence east four feet to the point of beginning.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding for consecutive weeks on 10/6/95 & 10/13/95.

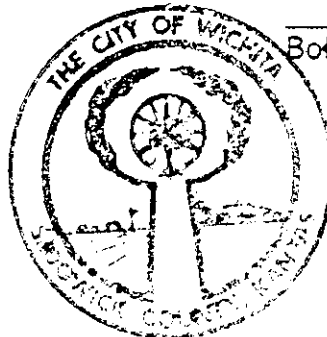

5. The vacation of the utility easement described herein should be approved.
