A 10-foot utility easement along the south line of Vautravers Addition, Wichita, Sedgwick county, Kansas, being described as the south 10 feet of the west 258.21 feet except the west 20 feet.

and

A 10-foot utility easement along the north line of A.M.F. Addition, Wichita, Sedgwick County, Kansas, being described as the north 10 feet of the west 175 feet except the west 20 feet.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this vacation proceeding one time on 11-18-97, which was at least 20 days prior to the date set for public hearing thereon.
2. No private rights will be injured or endangered by the vacation of the above-described utility easement, and the public will suffer no loss or inconvenience thereby.
3. In justice to the petitioner(s), the prayer of the petition ought to be granted.
4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.
5. The vacation of the utility easement described herein should be approved.

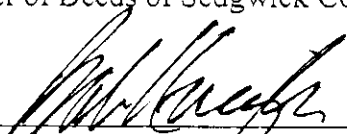

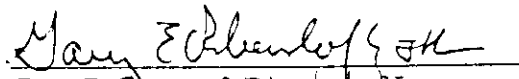

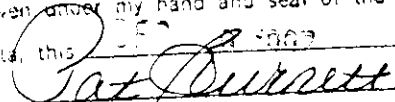
