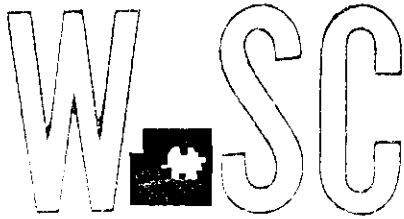

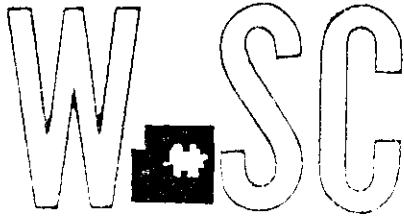

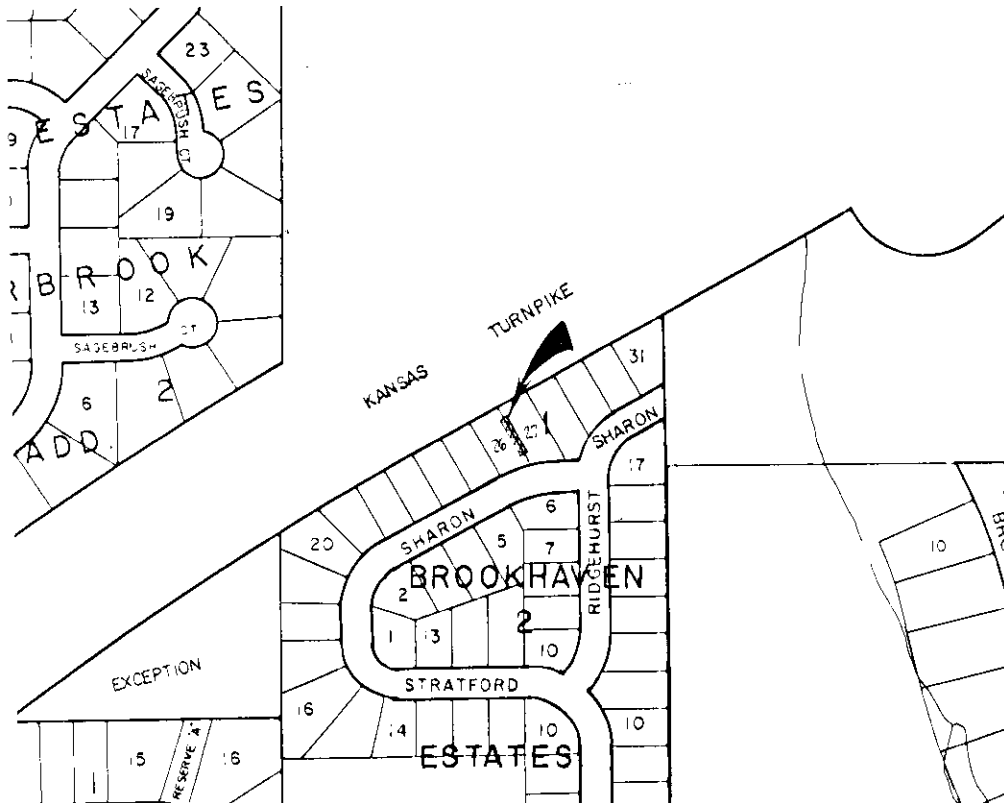
LEGAL DESCRIPTION: The 10 foot utility easement 5 feet on either side of the common line between Lots 26 and 27, Block 1, Brookhaven Estates 2nd Addition to Sedgwick County, Kansas; except the northerly 20 feet and the southerly 25 feet thereof.

LOCATION: Generally located on Sharon west of Ridgehurst.

REASON FOR REQUEST: Converting 11 Lots into 10 building sites for larger homes.

CURRENT ZONING: "SF-6" Single Family
