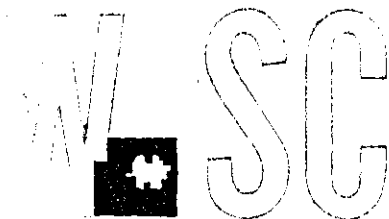

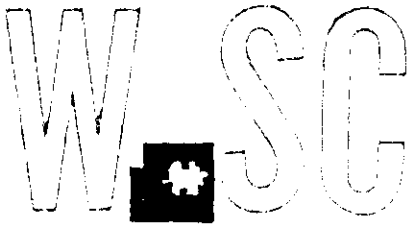

OWNER/APPLICANT: Randy Unruh, P.O. Box 3391, Wichita, KS 67201

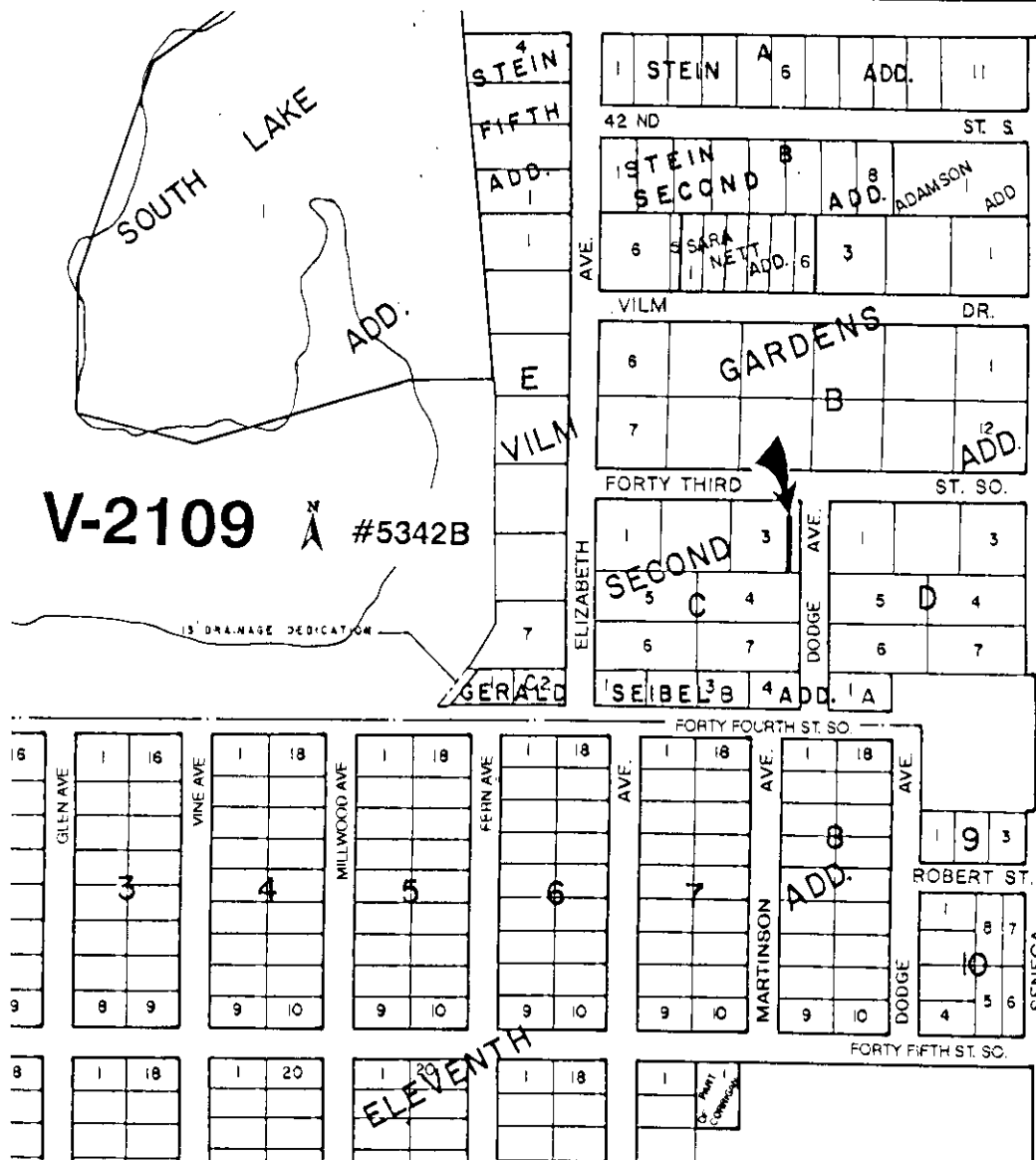

LEGAL DESCRIPTION: The west 15 feet of the east 30 feet of Parcel #2 of Lot 3, except the north 30 feet thereof, Block C, Vilm Gardens 2nd Addition.

LOCATION: Southwest corner of 43rd Street South and Dodge

REASON FOR REQUEST: This would allow for the construction of a building on-site.

CURRENT ZONING: "MF-18"

VICINITY MAP:

This lot (142 feet by 147 feet) was split into two separate lots earlier this year. Parcel 2 is the east half of the original lot (71 feet by 147 feet). The original plat had a 30 foot building setback platted on the east side which would only leave 36 feet for a building to be constructed on this lot. Therefore the applicant is requesting to vacate 15 feet of this 30 foot platted setback to a 15 foot street side setback. The Unified Zoning Code requires all lots which are zoned "MF-18" to maintain a 20 foot street yard setback. The applicant will be required to apply for a variance to reduce the street side setback from 20 feet to 15 feet.

SUBDIVISION COMMITTEE'S RECOMMENDED APPROVAL SUBJECT TO THE FOLLOWING
CONDITION:

- A. The applicant shall submit an application for a variance to reduce the street yard setback from 20 feet to 15 feet. The vacation request will not be scheduled for City Council approval until such time the variance request has been approved by the BZA.
