VACATION ORDER

NOW on this 14th day of April, 1998, comes on for hearing the petition for vacation filed by Matrix Aviation, Inc., praying for the vacation of the following described building setback, to-wit:

The south 40 feet of the 50 foot platted building setback line along the north property except for the east 50 foot of the platted building setback line Lot 14, Block 2, Airport Industrial Park, Wichita, Sedgwick County, Kansas.

The City Council, after being duly and fully informed as to fully understand the true nature of this petition and the propriety of granting the same, makes the following findings:

1. That due and legal notice has been given by publication as required by law, by publication in the Daily Reporter of notice of this one time 3-19-1998, which was at least 20 days prior to this public hearing.

2. No private rights will be injured or endangered by the vacation of the above-described building setback, and the public will suffer no loss or inconvenience thereby.

3. In justice to the petitioner(s), the prayer of the petition ought to be granted.

4. No written objection to said vacation has been filed with the City Clerk by any owner or adjoining owner who would be a proper party to the petition.

5. The vacation of the building setback described herein should be approved, subject to the following conditions:

A) The vacation will not include the eastern 50 feet of building setback along Hoover Road.

B) Any relocation or reconstruction of any utilities made necessary by this vacation shall be the responsibility of the applicant.

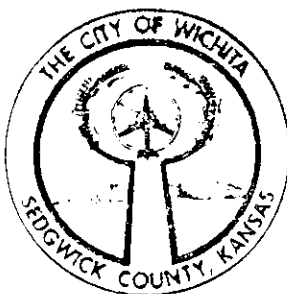
