SUBJECT: V-2164 - REQUEST TO VACATE A PORTION OF A BUILDING SETBACK LOCATED IN AN AREA AT THE SOUTHEAST CORNER OF 47TH STREET SOUTH AND BROADWAY. (District IV)

INITIATED BY: Metropolitan Area Planning Department *M. K. Hout*

AGENDA ACTION: Planning

Staff Recommendation: Approve vacation of building setback.

MAPC Recommendation: Approve vacation of building setback. (unanimous)

Background: The applicant is requesting to vacate a portion of a platted building setback to allow for the construction of an ATM. The applicant has submitted a site plan which shows an ATM located within the 100 foot platted building setback line. The Traffic Engineer has reviewed and approved the applicant's plan.

No one spoke in opposition to this request at the MAPC's advertised public hearing, and the MAPC voted to approve the vacation, adopting the findings of fact that are incorporated in the Vacation Order, subject to conformance with the site plan and to submitting an administrative adjustment to reduce the 100 foot setback on the Kmart Plaza South Shopping Center C.U.P. (DP-68). The adjustment request has been submitted. No written protests have been filed.

Legal Considerations: A certified copy of the Vacation Order will be recorded with the Register of Deeds.

Recommendations/Actions: Follow the recommendation of the Metropolitan Area Planning Commission and approve the Vacation Order, and authorize the Mayor to sign.

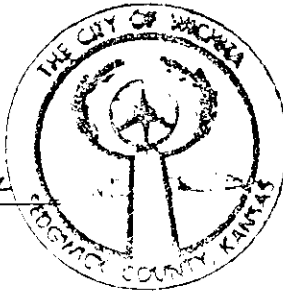
5. The vacation of the building setback described herein should be approved, subject to the following condition:

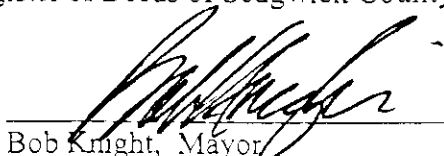
- A) The applicant will be required to submit an administrative adjustment to reduce the 100 foot setback on the Kmart Plaza South Shopping Center C.U.P. (DP-68).
- B) The site shall be developed in conformance with the approved site plan.
- C) Any relocation or reconstruction of any utilities made necessary by this vacation shall be the responsibility of the applicant.

IT IS, THEREFORE, BY THE CITY COUNCIL, on this 13th day of April, 1999, ordered that the above-described building setback is hereby vacated. IT IS FURTHER ORDERED that the City Clerk shall certify a copy of this order to the Register of Deeds of Sedgwick County.

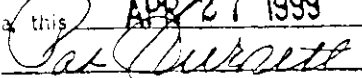
