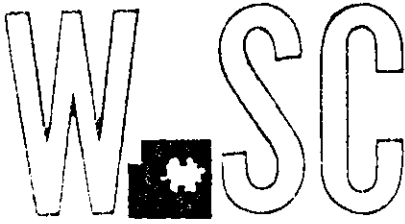

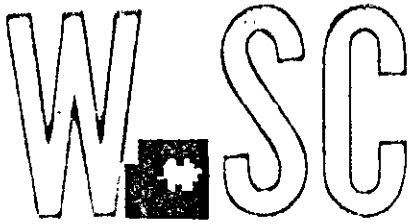

At the regular meeting of the Subdivision Committee of the Metropolitan Area Planning Commission, Thursday, November 5, 1998, the above-captioned vacation request was considered. The action of the Committee was to recommend that this vacation be approved subject to:

- A. The applicant shall provide the City of Wichita Water Department a site plan in order for the Water Department to determine if there is any impact on its' facilities in the area.
- B. A survey shall be completed to determine the exact location of a sewer line in the area. Based on the survey the applicant shall either abandon the sewer line or relocate the line.
- C. The applicant shall determine the location of a four inch gas line in the area and shall relocate the line if it is determined the construction will affect this line.
- D. Any relocation or reconstruction of utilities made necessary by this vacation shall be the responsibility of the applicant.

CASE NUMBER: V-2137 - Request to vacate a portion of a 20 foot buildings setback

OWNER/APPLICANT: Wesley Medical Center, c/o Carl W. Fitch, Sr.

AGENT: Gossen Livingston Associates Inc., c/o Nancy Steele

LEGAL DESCRIPTION: A tract of land lying in a portion of Lot 1, Wesley Medical Center Addition, an addition to Wichita, Sedgwick County, more particularly described as:

Tract 1:

Commencing at the southwest corner of Section 14, Township 27S, Range 1E; thence north along the west line of said Section, 477.86 feet; thence east perpendicular to the west line of said Section, 30 feet to a point on the west line of said Lot, the point of beginning; thence north along the west line of said Lot, 45.95 feet; thence east perpendicular to the west line of said Lot, 20.00 feet; thence south parallel to the west line of said Lot, 45.95 feet; thence west perpendicular to the west line of said Lot, 20 feet to the point of beginning.

Tract 2:

Commencing at the southwest corner of Section 14, Township 27S, Range 1E; thence north along the west line of said Section, 562.62 feet; thence east perpendicular to the west line of said Section, 30 feet to a point on the west line of said Lot, the point of beginning; thence north along the west line of said Lot, 10 feet; thence east perpendicular to the west line of said Lot, 20.00 feet; thence south parallel to the west line of said Lot, 10 feet; thence west perpendicular to the west line of said Lot, 20 feet to the point of beginning.

Tract 3:

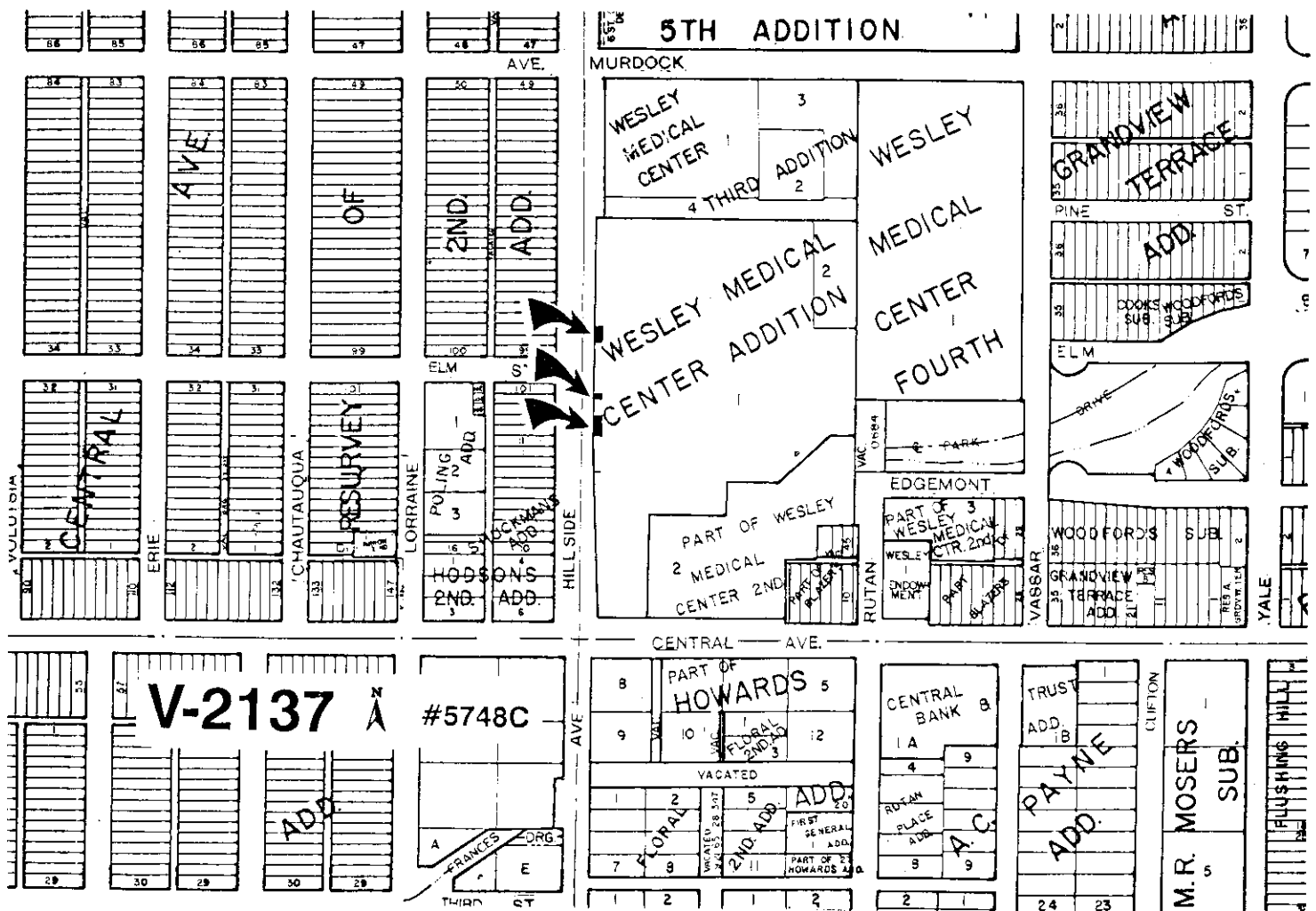
Commencing at the southwest corner of Section 14, Township 27S, Range 1E; thence north along the west line of said Section, 691.91 feet; thence east perpendicular to the west line of said Section, 30 feet to a point on the west line of said Lot, the point of beginning; thence north along the west line of said Lot, 38 feet; thence east perpendicular to the west line of said Lot, 20.00 feet; thence south parallel to the west line of said Lot, 38 feet; thence west perpendicular to the west line of said Lot, 20 feet to the point of beginning.

LOCATION: North of Central and east of Hillside

REASON FOR REQUEST: To allow for new construction

CURRENT ZONING: "GO" General Office

The applicant is requesting to vacate a portion of a 20 foot building setback. This would allow for the construction of a covered area and a pharmacy drive thru. The applicant has submitted a variance request to reduce the front yard zoning setback. This request will be heard by the BZA on November 17, 1998.

SUBDIVISION COMMITTEE RECOMMENDS APPROVAL SUBJECT TO THE FOLLOWING CONDITIONS:
